**SUBJECT: NOTICE FOR SUSPENSION OF REGISTRATION U/S 25 OF THE ACT-2011**

Whereas, section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 provides that registration of a registered person can be suspended where registered person "has failed to comply with its obligations under this Act". Rule 10 of the Sindh Sales Tax on Services Rules, 2011 also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax or non-filing of returns for four consecutive tax periods, the Board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

02. During the scrutiny of tax profile(s) it transpires that SRB's registered persons as per list attached (Annexure-A) have failed to file their Sindh sales tax monthly returns within the stipulated time for four (or more) consecutive tax periods in violation of the provisions of section 30 of the Sindh Sales Tax on Services Act, 2011 (*hereinafter referred to as "Act, 2011"*) read with rule 11, 12, 13, 14 of Chapter-III of the Sindh Sales Tax on Services Rules, 2011 of the aforesaid tax periods.

03. Subsequently, they have also failed to deposit due tax involved on taxable services provided or rendered by them to various companies which involves handsome amount of SST during different tax period(s) as per the list attached. However, they have failed to discharge Sales Tax liability and deposit the same in Government exchequer.

04. Therefore, in term of Section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 read with Rule 10 of the Sindh Sales Tax on Services Rules, 2011 and Circular No.02 of 2013, Sindh sales tax registration of 03 (three) SRB registered persons as per attached list are hereby **Suspended** u/s 25(3) of the Sindh Sales Tax on Services Act, 2011 with immediate effect until further orders.
