Subject: ORDER FOR RESTORATION OF REGISTRATION OF M/S. BST SERVICES (SNTN: 2265173-0)

02. M/s. BST SERVICES was suspended for alleged non-compliance for non-payment of Sindh Sales Tax and non-filing of monthly sales tax returns for various taxable periods. In response, Mr. Azeem Khan, AR, of **M/s. BST SERVICES** appeared on 17-08-2020, 23-08-2020 and 31-08-2020. The AR submitted Cheque No.A-32889936 of M/s Meezan Bank in favor of Sindh Revenue Board amounting **Rs.3,163,160/-** which was alleged short payment. AR , also requested that their SRB registration may kindly be restored so that they can file monthly sales tax returns (SST-03).

03. I have heard the representative of **M/s. BST SERVICES** and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN. Since, **M/s. BST SERVICES** has submitted copy of Cheque in favor of Sindh revenue Board and has undertaken to make compliance with the department. Therefore, taking a lenient view and for purpose of carrying on their business activity and subsequent remedial actions to be taken by the registered person, this office notice dated 06-08-2020, the suspension of the registered person is hereby **revoked with immediate effect**. In case of failing to fulfilment of stated remedial actions, registration of taxpayer may be subject to suspension.

04. **M/s. BST SERVICES** are further required to;

- i. e-file the tax returns within three days of issuance this notice, in the time and manner prescribed under the provisions of the Act, 2011 and rules made thereunder.

05. The case is disposed of accordingly.


