SUBJECT: **RESTORATION OF SINDH REVENUE BOARD REGISTRATION.**

Kindly refer to this office earlier letter to taxpayer enlisted below, on the subject matter, whereby, it was requested to place their SRB registration under suspension in terms of Section 25(1)(a)(ii) of Sindh Sales Tax on Services Act, 2011 and the Rules made thereunder.

In continuation of the above correspondence, it is to inform that below taxpayer appeared and submitted their response and they have been informed that due to unavoidable circumstances they fail to file monthly sales tax return, furthermore the registered person is ready to pay the Sales Tax on Services due and the registered person has also stated that in case of non-compliance or non-filing in future, penal action shall be initiated under the law.

In view of the foregoing position, it is requested that the SRB registrations of the taxpayer as listed below, may be restored on with immediate effect, under intimation to the undersigned, so that henceforth, this taxpayer may be able to file his due Sindh sales tax returns and pay the due amount of Sindh sales tax on services in the normal course.
