Subject: **ORDER FOR RESTORATION OF SST REGISTRATION NO. S3756783-7 IN RESPECT OF M/S ARABIAN PERAL ENGINEERING.**

The SRB Regional Office, Sukkur *vide* its letter No.SRB-SUK-CE-140/160/33027 dated 27th October, 2021 has suspended the Sindh sales tax registration No. S3756783-7 of M/s Arabia Pearl Engineering (*hereinafter to be referred as 'the registered person'*) on account non-compliance and non-submission of record for reconciliation of input tax claimed during the tax period from July, 2015 to February, 2021.

02. M/s S.M. Ramzan Gillani, Advocate and authorized representative of the registered person, has requested *vide* his letter No. GLC/APE/2021/1034 dated 04th November, 2021 this office to restore their client Sindh sales tax registration number, as the Assistant Commissioner (Unit-33), SRB has neither his jurisdiction nor concurrent power to call any record/ information from their client, as their client is not engaged in any economic activity within the territorial jurisdiction of Unit-33 notified *vide* SRB notification No.SRB-3-4/21/2021 dated 13th July, 2021. He further informed that his client provides taxable services to the following persons, which are located and registered with SRB Office, Karachi and they have received taxable services within the territorial jurisdiction of Karachi Division:-

The contention of the registered person is examined and checked in light of aforesaid SRB's jurisdiction order/notification and case was forwarded to the Competent Authority *i.e.* Member (Operations), SRB. After the examination, the Competent Authority has been pleased to restore the Sindh sales tax registration No.S3756783-7 of M/s Arabian Pearl Engineering subject to the condition that the registered person shall submit the requisite information/record in the office of the undersigned to assess and determine the tax liability, *if any*.

- d) Party wise ledger; and
- e) Income tax returns for the FY 2015-16, 2016-17, 2017-18, 2018-19 and 2019-20.
