**ORDER OF REVOKING OF SUSPENSION IN CASE OF  
M/S MEHAR IMPEX SNTN #: S0287669-8 CHAL No. 474**

Wherein, **M/s. MEHAR IMPEX** bearing SNTN S0287669-8 are registered with SRB since 10<sup>th</sup> August, 2011 in the service category of 'Custom Agent' classified vide tariff heading 9805.4000 to the second schedule of the Sindh Sales Tax on Services Act, 2011 'Act-2011'. As per the provisions of section 3, 5, 8, 9, 13, 17 and 30 of the Act-2011 read with rule 37 and rules enumerated in the Chapter-III of the Sindh Sales Tax on Services, Rules, 2011, the registered person had to deposit the SST and e-file the SST return [SST Form-03] in the time, manner and mode as prescribed in the Act *ibid*.

2. Reference to order dated 20<sup>th</sup> June, 2019, wherein the registration of the registered person was suspended in terms section 25 of the Act-2011 read with Circular No. 02 of 2013 and rules enumerated in the rule 10 of the Rules, 2011 issued against violation of section 30 of the Act-2011 and rule 12 of the Rules-2011 for non-filing of true and correct SST returns [SST Form-03] for the tax period *Apr-2018, May-2018, Jun-2018, Jul-2018, Aug-2018, Sep-2018, Oct-2018, Nov-2018, Dec-2018, Jan-2019, Feb-2019, Mar-2019 and Apr-2019*.

3. In compliance Mr. SHIRAZ AHMED, Advocate High Court on behalf of the registered person submitted letter dated 8<sup>th</sup> November, 2022 received to this office bearing inward No. 38043 wherein they submit as:

*It is stated that due to some personal issue, my said client has shifted to Lahore and was unable to submit its 10 month SRB return due to which registration was suspended on June-2019 and after that ID password of SRB login was also blocked, that non-filing of the SRB return was not intentionally, deliberately and wilfully but due to unavoidable circumstances and crises of our client's family and business.*

*It is pertinent to mention here that no business has been done for 4 years, our bank account has been dormant being of no transaction and our custom license was also blocked and no tax is outstanding against my said client.*

*Now my said client is willing to start its business and ready to pay current due taxes according to the applicable provision of law. In support of our request undersigned is submitting following document for your kind consideration.*

1. *Income tax return (2019-2022)*

*In light of above reason, your good self is requested to please restore Sindh sales tax registration and waived penalty for non-filing of SRB return and provide ID Password of our above named client.*

4. Based on above submissions of the registered person and perusal of their submitted record, it can be inferred that no business activity have been commenced during the tax periods confronted, however, the registered person shall be liable to deposit the SST if identified to be short paid during the subject tax periods. Moreover, they also undertake to deposit the SST and e-file their SST returns [SST Form-03] on time in compliance with the provisions of the Act-2011 and rules made thereunder.

5. Therefore, taking a lenient view and for the purpose of ease of doing business, the registered person were advised to deposit the penalty amount worth **Rs. 100,000/-** in terms of Serial No. 2 of the Table under section 43 of the Act-2011 in to the Sindh Government head of account '**B-02384**'. It is to apprise that suspension of the registered person is hereby revoked with immediate effect being compliant to the following conditions and undertaking:

- i. That the registered person have deposited SST worth **Rs. 100,000/-** recoverable in terms of Serial No. 2 of the Table under section 43 of the Act-2011 vide CPR No. **S1-20230104-0044-1142399** dated 4<sup>th</sup> January, 2023.
- ii. Deposit the SST and e-file all the tax periods from **February, 2018** till **October, 2022** in terms of provisions of section 17 and 30 of the Act-2011 read with rules enumerated in Chapter-III of the Rules-2011 latest by or before the **18<sup>th</sup> day of January, 2023**.

6. In view of the above conditions and commitment of the registered person, I order to activate the User ID and Password of the registered person for depositing the recoverable SST in to the Sindh Govt. Exchequer '**B-02384**' beside the levy of default surcharge under section 44 of the Act-2011 and file Sindh sales tax returns latest by or before the **18<sup>th</sup> day of January, 2023**, suspension hereby stands revoked.
