**ORDER FOR RESTORATION OF SUSPENSION**

| Reason for Suspension           | Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder |

Whereas, **M/s Zenith Security Services (Private) Limited SNTN#1520995-4** are registered with Sindh Revenue Board under the category of “Security Agency” classified under tariff heading 9818.1000 to the second schedule of Sindh Sales Tax on Services Act, 2011 (hereinafter “Act, 2011”)

2. Scrutiny of tax profile revealed that they have failed to comply with the obligations of the Act, 2011. The registered person failed to make payments of Sindh Sales Tax on Services amounting to Rs.313,370/-, December 2013 to January 2018, under section 17 of the Act 2011, failed e-file their SST returns for the tax period December 2013 to January 2018 under section 30 of the Act 2011 and failed to submit the printed copy of Annual Audited Accounts for the years ended 2014, 2015, 2016 & 2017 under section 26(5) of the Act 2011.

3. Accordingly, notice bearing NO. SRB-COM-II/AC-U-15/S.A/2018/1013 dated 20<sup>th</sup> March, 2018 was served upon the registered person under section 25(1)(a)(ii) of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of M/s Zenith Security Services (Private) Limited was suspended for the violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provision of the Act, 2011 and the rules made thereunder.

4. On 17.12.2018, 15.01.-2019, 29.01.2019 and 31.01.2019 M/s Zenith Security Services (Private) limited were called upon for the hearing in the case of suspension. In the last hearing on dated 29.01.2019 Major @ Syed Jafar Sadiq Nizam and Mazhar Abbasi (Manger Operations) appeared for hearing, they stated that they are willing to pay subject SST dues and further requested that they have already paid Rs.100,000/- against suspension vide Askari Bank order No.04609211, dated 30.03.2018. Moreover they have submitted written submission for restoration of their registration on their letter head. Same is reproduced as under:
