## **NOTIFICATION**

(Sindh Sales Tax on Services)

No. SRB-3-4/27/2020 ------ In exercise of the powers conferred by sub-section (1) of section 34 of the Sindh Sales Tax on Services Act, 2011 (Sindh Act No. XII of 2011), read with sections 35 and 36 thereof, the Board is pleased to direct that the following further amendments shall be made in its notification No. SRB-3-4/24/2020 dated 3<sup>rd</sup> July, 2020, namely:-

(8) after S. No. 67. in column (1) and the entries relating thereto in columns (2), (3) and (4), the following shall be inserted, namely:-

- (12) against S. No. 87 in column (1), for the words "Mr. Usama Javed Siddiqui" in column (2) relating thereto, the words "Ms. Pirah Ashfaque" shall be substituted;
