Non-compliance of the section 2(71), 3, 5, 8, 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder.

ORDER OF REVOKING OF SUSPENSION IN CASE OF M/s. A & S **ENTERPRISES**

M/S. A & S Enterprises (NTN-S2577943-5), Suit No 14, First Floor, Al-Rehman Avenue 15, Karachi, are engaged in providing and rendering the taxable services of 'Custom Agent' falling under tariff heading 9805.4000 of the Second Schedule to the Sindh Sales Tax on Services Act, 2011 which are chargeable to sales tax under section 3 of the Sindh Sales Tax on Services Act, 2011 at the rate of 15%.

- In response to the notice No. AC/CA/COM-II/SRB/S-01/2014/0582 dated 25th March 2015, the representative of M/s. A & S Enterprises appeared for hearing and also submitted written reply vide letter no Nil dated 3rd April,2015 to clarify their position on above matter, that A & S Enterprises has deposited all SRB Charges/ Tax dues on NTN 0625246-0 which is also registered with SRB instead of NTN 2577943-5.
- The representative of M/s. A & S Enterprises Ltd vide their Letter Nil dated 03.04.2015, have requested to activate their registration status so that they can file all of their pending Sindh sales tax returns (Form SST-03). He has further requested to intimate all persons regarding withdrawal of suspension to whom the letter of suspension was delivered.
- In view of all above, since, M/s. A & S Enterprises took the major remedial action and clarify their position on the above matter, therefore, taking a lenient view and for the purpose of carrying on their business activity, the suspension of the registered person is hereby revoked with immediate
