NOTICE FOR SUSPENSION OF REGISTRATION OF M/S. ACHTUNG SECURITY (PVT.) LIMITED HAVING SNTN: 2527102-4

Whereas, section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 provides that registration of a registered person can be suspended where registered person "has failed to comply with its obligations under this Act". Rule 10 of the Sindh Sales Tax on Services Rules, 2011 also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax, the Board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

- 2. Whereas, scrutiny of your Sindh Sales Tax profile reveals that you have failed:
 - make the payment of Sindh sales tax on services as required under section 9 and section 17 of the Act, 2011, read with rule 14 & 42D of the Rules, 2011 from the tax periods April, 2018 to June, 2019;
 - e-file the true & correct Sindh sales tax return (Form SST-03) as required under section 30 of the Act, 2011 read with rule 12, 13 & 42D of the Rules, 2011 for the aforesaid tax periods;
- 3. Therefore, it is to inform you that non-payment of Sindh sales tax and non-filing of true & correct Sindh sales tax return within the prescribed time limit and manner under the

law are the contravention of aforesaid provisions of the Act-2011 and the rules made thereunder. The record available with this office shows that you have provided taxable services to different service recipient's for total value amounting to Rs. 218,319,387/- involving SST amount of Rs. 26,526,075/-. However, the service recipients have withheld the SST amounting to Rs. 5,297,034/- and the registered person have charged, collected the remaining SST amount of Rs. 21,229,041/-, but deposited only amounting to Rs. 8,307,822/-. Consequently, the registered person has short paid/not paid the remaining SST amount of Rs. 12,921,219/- with SRB (Annexure enclosed). Therefore, such act of misrepresentation, and concealment of the actual facts are the serious violations of aforesaid provisions of the Act-2011 and the rules made thereunder.

- 4. This office has, several times, informed you in writing, through telephonic discussions, about the aforesaid offences committed by you but, neither you deposited the amounts of Sindh sales tax due nor e-filed the monthly Sindh sales tax returns as required. This is the serious violation of the above referred statutory provisions of the Act-2011 and the Rules made thereunder.
- Now, this notice is being issued to you under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011 to the effect that your registration is hereby suspended with immediate effect. However, your suspension shall be revoked if you take following remedial actions by 14-10-2019;
 - to discharge all the due Sindh sales tax liability along with default surcharge under section 44 of the Act-2011 under the Government of Sindh head of account B-02384, for the aforementioned tax periods and deposit the due tax amount;
 - to e-file the true and correct monthly Sindh sales tax returns (Form SST-03) for the said tax periods.
- 6. In case of non-satisfactory response or failure to take remedial measures as suggested above on or before 14-10-2019, your case shall be proceeded for cancellation of your SRB registration. Furthermore, your case shall also be forwarded to the Home Department Government of Sindh for revocation of license on account of contravention/violation of the aforementioned provisions read with section 72A of the Act, 2011 and also read with the section

- 8 & section 10 of the Sindh Private Security Agencies (Regulation and Control) Ordinance, 2000.
- 7. This notice and suspension of registration are without prejudice to the penal action; prosecution action and recovery action as may be taken against M/s. Achtung Security (Pvt.) Limited in accordance with the provisions of the Act or the Rules.
