## SUBJECT: NOTICE FOR SUSPENSION OF REGISTRATION OF M/s.Peerzada International (SNTN-1367341-1).

Whereas, section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 provides that registration of a registered person can be suspended where registered person "has failed to comply with its obligations under this Act". Rule 10 of the Sindh Sales Tax on Services Rules, 2011 also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax, the Board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

2. Whereas, scrutiny of your tax profile reveals that you have processed 347 GD's in Sindh during July-2011 to February-2014, and have thus provided the taxable services of Custom Agent in province of Sindh. But have failed to:

- to make the payment of Sindh sales tax on services as required under section 3, 5, 8, 9 and 17 of the Sindh Sales Tax on Services Act, 2011, read with rule 14 of the Sindh Sales Tax on Services Rules, 2011, pertaining to the tax periods July-2011 to February-2014,
- to e-file the Sindh sales tax return (Form SST-03) as required under section 30 of the Sindh Sales Tax on Services Act, 2011 (Act-2011) read with rule 12 of the Sindh Sales Tax on Services Rules, 2011(Rules-2011), in the time limitation and the manner as prescribed under rule 13 of the Rules-2011, for the tax periods from July-2011 to October-2014;

3. Thus you have violated section 2(71), 3, 5, 8, 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011, and rule 14 and 12 of the Sindh Sales Tax on Services Rules, 2011, and have thus failed to comply with your obligation under this act.

4. Now, this notice is being issued to you under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on www.srb.gos.pk Tel: 021-99217800 Email: ac.13@srb.gos.pk Services Rules, 2011 to the effect that your registration is hereby suspended with immediate effect. However, your suspension shall be revoked if you take following remedial actions by 18.12.2014;

- To discharge all your sales tax liability for aforementioned tax periods and deposit the same in the Government of Sindh head of account B-02384.
- to e-file the true and correct monthly Sindh sales tax returns (Form SST-03) for the tax periods from July-2011 to October-2014.

5. In case of non-satisfactory response or failure to take remedial measures as suggested above on or before 18.12.2014, your case shall be further processed for cancellation of your registration with SRB.

6. This notice and suspension of registration are without prejudice to the penal action, prosecution action and recovery action as may be taken against M/s. Peerzada International in accordance with the provisions of the Act or the Rules.
