Subject: **ORDER FOR SUSPENSION OF REGISTRATION OF M/S JIPU CONSTRUCTIONS (PRIVATE) LIMITED (SNTN: 7614117-0).**

Whereas, section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 (hereinafter "Act, 2011") provides that registration of a registered person may be suspended where registered person "has failed to comply with its obligations under this Act". Rule 10 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter "Rules, 2011") also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax or non-filing of returns for four consecutive months, the Board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

2. Whereas, scrutiny of your tax profile reveals that, you have failed;

- i. you keep the abnormal tax profile on account of made/declared abnormal purchases and also failed to attach the purchase invoices with Sindh sales tax returns, which is the violation of Rule 16 of the Rules, 2011;
- ii. you have failed to comply this office earlier notices dated 31.03.2021 and 05.04.2021 issued on account of non-filing of Sindh sales tax returns from July, 2020 to date and non-payment of due Sindh sales tax amount;
- iii. you were not existing at your registered head office address *i.e.* Banglow No. # 84, Khayaban-e-Rizwan, DHA Phase-VII, Karachi, during the course of physical verification, conducted by this office on 9th April, 2021 at 11:00AM; and
- iv. you have failed to update your SRB registration profile in terms of correspondence address, contact number(s), bank account and updated particulars of authorized representative, which is violation of Rule 10 of the Rules, 2011.

3. This order is being issued to you under section 25 of the Act, 2011 read-with Circular No. 02 of 2013 and Rule 10 of the Rules, 2011 to the effect that your registration is hereby **suspended** with immediate effect. However, your suspension shall be revoked if you take following remedial actions by **19th April, 2021** :-

- a) to personally appear before the undersigned and verified your registration particulars *like* Memorandum of Article, CNICs, Passport, VISA (*if any*), SECP registration Certificate, FBR Registration Certificate, Tenancy Agreement/Lease Documents, Last Paid Electricity Bill and Bank Statement of Last Twelve Months;

- b) after verification of above document, to online submit the change in particulars application for updating your SRB registration profile; and
- c) to submit the complete reconciliation statement in terms of your purchases made / declared in Sindh sales tax returns along-with following documents/record:-
- i) Visible and clear copies of Purchase Invoices;
 - ii) Proof of Payments along-with Bank Statement;
 - iii) Party-wise Ledger accounts;
 - iv) Contract/Agreement signed with M/s CEEC Tianjin (Pakistan) Electric Power Construction (Pvt.) Limited (SNTN # 7154050-4) and M/s China Energy Engineering Group Tianjin Electric Power Construction Co., Ltd. (SNTN # 7150858-7);
 - v) Copy of Last Income Tax Return filed with FBR; and
 - vi) Annual Audited Accounts for the year 2019-2020.

4. In case of non-satisfactory response or failure to take remedial measures as mentioned in para 3(a)(b) & (c) on or before above scheduled date, your case shall further be proceeded for legal action;

5. This order is issued without prejudice to the penal, prosecution and recovery action as may be taken against you in accordance with the provisions of the Act, 2011 or the Rules, 2011.

Limited till the restoration of its registration from suspension and/or issuing NOC from this office, failing which you shall also be held responsible in terms of Section 18 of the Act, 2011.
