**NOTIFICATION**  
**(Sindh Sales Tax on Services)**


SRB-3-4/6/2016.-----In exercise of the powers conferred by sub-section (1) of section 10 of the Sindh Sales Tax on Services Act, 2011 (Sindh Act No. XII of 2011), the Sindh Revenue Board, with the approval of the Government, is pleased to exempt the whole of the tax leviable on such of the services classified under tariff headings 9809.0000, 9815.5000 and 9824.0000 as are provided or rendered to Karachi Water & Sewerage Board (hereinafter called "the KW&SB") for the construction and completion of its K-IV Bulk Water Supply Project (hereinafter called "the K-IV Project"):

Provided that the exemption under this notification shall be available on one time basis only in respect of the services provided or rendered by M/S Frontier Works Organization (hereinafter called "FWO") for the construction and completion of the said K-IV project:

Provided further that while making payments to the FWO for its services covered by this notification, the Managing Director, KW&SB, shall issue a certificate in the form annexed with this notification and shall send a copy each of this certificate to the FWO and the Commissioner-II, Sindh Revenue Board, Shaheen Complex, Karachi, within 7 days of each such payments:

Provided further that this notification shall not entitle the FWO or the KW&SB to any refund of Sindh sales tax or to input tax credit/adjustment of any tax paid or payable on such services.

2. This notification will be valid only for the period during the construction and completion phase of the K-IV project and, if not rescinded earlier, this notification shall stand rescinded on the 30<sup>th</sup> day of June, 2018.
