ORDER FOR REVOCATION OF SUSPENSION

Name & SNTN of Person Suspended:	M/s. Ali Hamza Construction Company (SNTN#S7301478-3)
Address:	House at Mohalla Roshah Abad, District Shaheed Benazirabd, Sakrand, (Nawab Shah).
Date of Institution:	25-07-2017 (General Suspension Order)
Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods	March, 2017, April, 2017, May, 2017 and June, 2017

Brief facts of the case:

M/s. Ali Hamza Construction Company (Owner/proprietor Mr. Irshad Ali CNIC:41306-55229063), bearing SNTN#S7301478-3 is registered with SRB (*the "registered person"*) under the principal service category of "*Contractors of building (including water supply, gas supply and sanitary works), roads and bridges, electrical and mechanical works (including air conditioning), horticultural works, multi-discipline works (including turn-key projects) and similar other works*" covered under tariff heading 9814.2000 of the Second Schedule to the Sindh Sales Tax on Services Act, 2011 (*the "Act, 2011"*). The registered person was required to comply with the provisions of section 3, 8, 9, 17 & 30 of the Act, 2011 read with relevant rules of Sindh Sales Tax on Services Rule, 2011 (*the "Rules, 2011"*).

02. The SRB registration of **M/s. Ali Hamza Construction Company** was suspended vide SRB general suspension order bearing Ref:NO.SRB-COM-II/DC-13/Suspension Order/01/17-18/237571 dated 25.07.2017 issued under section 25 of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011. The SRB registration was suspended on account of non-filing of monthly Sindh sales tax returns for the tax periods March, 2017, April, 2017, May, 2017 and June, 2017.

03. Whereas, **M/s. Ali Hamza Construction Company** requested for restoration of SRB registration in hearing dated: 08-12-2021, the registered person stated that, in 2016 they got SRB registration and applied with different departments for award of tender but, unfortunately no award/tender have been awarded/achieved. Thereafter, Mr. Irshad proceeded to the Dubai for

work and support of family. Now he returned and intends to apply for tenders and for entitlement of the awards from different departments. Moreover, **M/s. Ali Hamza Construction Company** also deposited penalty amounting to Rs.40,000/- vide P.O No. Bc-05890125 dated 08-12-2021 in the name of SRB. Therefore, he requested for revocation of suspension as he can apply and try a chance for award of any contract and assured for full compliance of statutory provisions of the Act-2011 and rules made thereunder.

04. I have examined the facts & circumstances of the case and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on e/i.srb portal, due to which the taxpayer neither can e-file the return nor can generate the PSID on their own SNTN. Since, the **M/s. Ali Hamza Construction Company** have assured for full compliance of the provisions of the Act-2011 and rules made thereunder. Therefore, taking lenient view for the purpose of carrying on their business activity and to e-file monthly SST returns and also for depositing the due tax payments, the suspension of the registered person as per the provision of section 25(4) of the Act, 2011 are hereby **revoked with immediate effect.**

05. This order is without prejudice to any other action under the law for the time being in force. Therefore, the penal action and recovery action as shall be taken against the **M/s. Ali Hamza Construction Company**, in accordance with the provisions of the Act, 2011 and rules made thereunder.
