## ORDER FOR REVOCATION OF SUSPENSION

## **BRIEF FACTS OF THE CASE:**

M/s. Dada Builders (Owner/proprietor Mr. Hafeez Ur Rehman Memon CNIC: 4530281002623), bearing SNTN#S0931584-5 is registered with SRB (the" registered person") under the principal service category of "Services provided or rendered by persons engaged in contractual execution of work or furnishing supplies" covered under tariff heading 9809.0000 of the Second Schedule to the Sindh Sales Tax on Services Act, 2011 (the "Act, 2011"). The registered person was required to comply with the provisions of section 3, 8, 9, 17 & 30 of the Act, 2011 read with relevant rules of Sindh Sales Tax on Services Rule, 2011 (the "Rules, 2011").

of non-filing of monthly Sindh sales tax returns for the tax period(s) from September 2017 to March-2019.

Whereas, M/s. Dada Builders requested for restoration of SRB registration in hearing dated: 24-01-2022, the registered person stated that, he was unaware about the SRB Suspension and he came to know now when he intended to apply for tenders awarded by different departments. He also stated that he is facing severe cash flow issues and therefore cannot pay the total penalty amount for non-filling of the returns alleged in the suspension notice. Further, he produced Cheque No. 64384821 dated 24-01-2022 of UBL Mehrabpur branch as penalty

amounting to Rs.15,000/- in the name of SRB. He assured for full compliance of statutory provisions of the Act-2011 and rules made thereunder and requested for revocation of the suspension.

- 04. I have examined the facts & circumstances of the case and concluded that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on e/i.srb portal, due to which the taxpayer neither can e-file the return nor can generate the PSID on their own SNTN. Since, the M/s. Dada Builders have assured for full compliance of the provisions of the Act-2011 and rules made thereunder. Therefore, taking lenient view for the purpose of carrying on their business activity and to e-file monthly SST returns and also for depositing the due tax payments, the suspension of the registered person as per the provision of section 25(4) of the Act, 2011 are hereby revoked with immediate effect.
- 05. This order is without prejudice to any other action under the law for the time being in force. Therefore, the penal action and recovery action as shall be taken against the M/s. Dada Builders, in accordance with the provisions of the Act, 2011 and rules made thereunder.


