Subject: **ORDER FOR RESTORATION OF REGISTRATION OF M/S. PARADIGM ENGINEERING (PROPRIETOR MR. TARIQ ALI KHAN) HAVING SNTN # S3610511-2.**

This is with reference to your letter No. Nil dated 08th February, 2021 in response to this office letter of even number dated 27th October, 2018, whereby, your registration was suspended for alleged non-payment of Sindh Sales Tax of Rs.4,315,561/- and non-filing of monthly sales tax returns for various taxable periods.

02. Whereas, you have deposited SST total amount of Rs. 800,000/- vide CPR No. S1-20210112-0085-1552457 dated 12th January, 2021 and CPR No. S1-20210204-0113-1076895 dated 04th February, 2021. Further, you have requested to restore your registration with SRB and tax demand may be created after reconciliation.

03. I have considered the aforesaid request of **M/s. Paradigm Engineering** and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN. Since, **M/s. Paradigm Engineering** have deposited SST amount of Rs. 800,000/- into the Govt. treasury and has undertaken to reconcile and deposit due amount of SST with SRB. Therefore, taking a lenient view and for purpose of carrying on their business activity and subsequent remedial actions to be taken by the registered person, this office notice dated 27th October, 2018, the suspension of the registered person is hereby **restored with immediate effect**. In case of failing to fulfilment of stated remedial actions, registration of taxpayer may be subject to suspension.

04. **M/s. Paradigm Engineering** are further required to:-

e-file true and correct pending Sindh Sales tax returns within three days of issuance this notice, in the time and manner prescribed under the provisions of the Act, 2011 and rules made thereunder.
