Subject: **ORDER FOR PROVISIONALLY RESTORATION OF SST REGISTRATION OF M/S. H2 READY-MIX (PVT.) LTD. HAVING SNTN # S4109930-3.**

This is with reference to your letter No. Nil dated Nil received to this office on 09th November, 2021 in response to this office notice of even No.33505 dated 29th October, 2021, whereby, your registration was suspended for alleged non-filing and non-payment of due Sindh sales tax for the tax periods June- 2021 to September-2021 and non-submission of record/documents.


02. Whereas, Mr. Muhammad Zahoor, Tax Consultant of M/s. Moore Shekha Mufti (chartered Accounts), duly authorized by you, appeared on your behalf and requested this office to restore your Sindh sales tax registration. He has committed on your behalf that, the due Sindh sales tax amount for the tax periods June-2021 to September-2021 shall be deposited into the Sindh Government treasury and also file monthly sales tax returns for the same tax periods within seven working days from the date of restoration. Further, you will also submit copy of Form "R" for the tax year 2020-21 along-with copy of purchase invoices in respect of input tax claimed for said tax periods. He also submitted an undertaking in this regard, duly signed by the director of M/s. H2 Ready-Mix (Pvt.) Limited for such compliance.

03. Keeping a lenient view, I have considered the aforesaid request of **M/s. H2 Ready-Mix (Pvt.) Limited** and concluded that, on suspension of registration of a taxpayer, the complete tax profile of registered person has been blocked on *srb* portal and the taxpayer neither can e-file the returns nor can generate the PSID on its NTN. Since, **M/s. H2 Ready-Mix (Pvt.) Limited** has undertaken to deposit due amount of SST with SRB and also submit requisite record. Therefore, for purpose of carrying on their business activity, the suspension of the registered person is hereby **provisionally restored with immediate effect**, in case of failure to deposit due SST amount with SRB and non-submission of requisite record within seven working days from this restoration order, your Sindh sales tax registration shall again suspend without any further notice.
