ORDER FOR SUSPENSION OF REGISTRATION OF M/s. S B ENTERPRISES (SNTN-S3759900) UNDER SECTION 25 (1)(a)(ii)

Whereas, section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 provides that registration of a registered person can be temporary suspended where registered person "has failed to comply with its obligations under this Act". Rule 10 of the Sindh Sales Tax on Services Rules, 2011 also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax, the Board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

2. Scrutiny of SRB tax profile reveals that you have declared taxable services and have self-assessed output tax payable thereon amounting to **Rs. 4,997,594** for the tax periods Mar-17 to Jun-17 & Aug-17 to Jul-19; however, you have under taken to pay the due amount of Sindh sales tax if you have been allowed to pay the same in instalment, besides you have also submitted the undated cheques amounting to Rs. 4,997,594/- for assuring the payment of Sindh sales tax thereon. Thereafter, with the approval of the competent authority and considering the economic condition due to pandemic in the world M/s SB Enterprises was allowed to pay in following manner:

However, M/s SB Enterprises has only paid an amount of Rs. 1,789,822/- in Sindh Government Treasury after issuance of Order for Revocation of Registration of Suspension of M/s SB Enterprises bearing no. SRB-Com-IV/AC16/TI/S-B-ENTERPRISES/2020/32630, dated 30.09.2020. Despite considering their request, the registered person failed to pay the remaining amount of Rs. 3,207,772/-, the breakup of payment of Rs. 1,789,822/- is given below:

Whereas, in view of the above, the registered person has failed to deposit Sindh sales tax amounting to Rs. 3,207,772/- in Sindh Government Treasury. This is tantamount to tax fraud which is defined under section 2(94) of the said Act, 2011. Please note that failing to deposit the amount of tax due or any amount thereof constitutes an offense punishable under serial no 3 of the Table under section 43 of the Act, 2011. Furthermore, the act of tax fraud is liable to be penalised under serial no. 6(d) of the Table under section 43 of the Act, 2011.

- 3. This office has informed you in writing vide SRB's letter No. 65213, dated 17.12.2020, about the aforesaid offence (i.e. failing to deposit the amount of tax due or any amount thereof) committed by you but, you have failed to deposit the said amount of Sindh sales tax due as required. This is a serious violation of the above referred statutory provisions of the Act-2011 and the Rules made thereunder.
- Now, this notice is being issued to you under section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011 to the effect that your registration is hereby suspended temporary with immediate effect, which shall be revoked if you take following remedial action by 13.01.2021;
 - To discharge your aforesaid self-declared Sindh sales tax liability of Rs. 3,207,772/- by depositing the same in the Government of Sindh head of account B-02384, along with default surcharge u/s 44 of the Act,
 - To provide bank statements of all bank accounts from July 2016 to July 2020,
 - To provide copies of income tax returns of FY 2016, 2017, 2018 & 2019.
- 5. In case of non-satisfactory response or failure to take remedial measures as suggested above on or before 13.01.2021, further proceedings shall be initiated against you as envisaged under the law without any further notice.
- 6. This notice and suspension of registration are without prejudice to the penal action, prosecution action and recovery action as may be taken against M/s. S B Enterprises in accordance with the provisions of the Act or the Rules.
