**ORDER FOR RESTORATION OF SNTN # S0519773-2
IN RESECT OF M/S ZAR INTERIOR DECORATOR & MAINTENANCE WORKS**

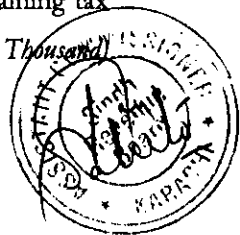

Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder

Whereas, M/s Zar Interior Decorator & Maintenance Works (*hereinafter referred to as 'the Company'*). having SNTN: S0519773-2 is registered with Sindh Revenue Board under the category of "Contractual Execution of works or furnishing supplies" defined under tariff heading 9809.0000 of the Second Schedule of Sindh Sales Tax on Services Act, 2011 (*hereinafter referred to as 'the 2011-Act'*).

02. Scrutiny of tax profile revealed that they have failed to deposit the SST amount of **Rs.5,744,815/-** as required under section 9 and 17 of the 2011-Act read-with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (*hereinafter referred to as 'the 2011-Rules'*). Moreover, the registered person has also failed to e-file true and correct Sindh sales tax returns, required under Section 30 read with Rule 11, 12, 13 and 14 of the said 2011-Rules.

03. The order for suspension was served to the Company under Section 25 of the 2011-Act read-with Rule 10 of the 2011-Rules, whereby the registration of the Company was suspended on account of violation of aforesaid provisions of the Act and rules made thereunder and advised to discharge due Sindh sales tax liability, as calculated above, and to submit the required document/record for reconciliation and restoration of their registration number.

04. The Company has requested to this office vide their letter No. Nil dated 12th March, 2021 submitted by its representative *i.e.* Mr. Irfan-ud-Din Siddiqui (CNIC # 42101-7689532-3), to restore the Sindh sales tax registration No. S0519773-2, as the Company is agreed to pay its tax liability and submitted a Pay Order No. 00004682 dated 11.03.2021 total amounting to **Rs.1,500,000/-** (*Rupees One Million & Five Hundred Thousand*) as well as he also requested to allow 08 instalments for remaining tax liability of Rs.500,000/- (*Rupees Five Hundred Thousand*) and Rs.600,000/- (*Rupees Six Hundred Thousand*) for alternate tax periods upto the month of November, 2021.



05. I have gone through the verbal and written submission of the Company and came to conclusion that, due to suspension of their Sindh sales tax registration, the tax return profile of the Company has been blocked in the SRB system and the Company is also unable to generate the PSID on its SNTN. Therefore, taking a lenient view and for purpose of carrying on their business activity and also subsequent remedial actions to be taken by the Company, I hereby ordered to revoke the suspension of Sindh sales tax registration No. S0519773-2 of M/s Zar Interior Decorator & Maintenance Works provisionally, subject to fulfil the following conditions and limitations:-

- i. *The Company shall responsible to clear aforementioned banking instruments within the time given time period(s);*
- ii. *The Company shall deposit the remaining short-paid Sindh sales tax amount along-with default surcharge, in following three equal installments into the Sindh Government's head of account No. "B-02384---Sindh Sales Tax on Services" without any further delay. Besides, the Company shall also deposit your regular Sindh sales tax payments without any delays.*
 - a) *Rs.1,414,940/- along-with default surcharge by 15th April, 2021;*
 - b) *Rs.1,414,940/- along-with default surcharge by 17th May, 2021; and*
 - c) *Rs.1,414,935/- along-with default surcharge by 15th June, 2021;*
- iii. *The Company shall e-file true and correct Sindh sales tax return(s), after getting approval of revision and condonation, if applicable, and also e-file their pending returns within thirty days of issuance of this Order.*
