

NOTICE FOR SUSPENSION OF REGISTRATION OF M/S. M. FARRUKH ASSOCIATES (SNTN: 2756584-0)

Whereas, section 25 (1) (a) (ii) of the Sindh Sales Tax on Services Act, 2011 provides that registration of a registered person can be suspended where the registered person has failed to comply with its obligations under this Act. Rule 10 of the Sindh Sales Tax on Services Rules, 2011 also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax, the board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

- 2. Whereas, scrutiny of your tax profile reveals that you have failed:
 - to e-file the Sindh sales tax return (Form SST-03) as required under section 30 of the Sindh Sales Tax on Services Act, 2011 (Act, 2011) read with rule 12 of the Sindh Sales Tax on Services Rules, 2011 (Rules, 2011), in the time limitation and the manner as prescribed under rule 13 of the Rules, 2011 for the tax periods January-2015 to February-2016
 - to deposit the Government dues amounting to Rs 180,000/- adjudged vide Order-in-Original No. 117 of 2014 dated 12.12.2014, Order-in-Original No. 261 of 2016 dated 04.03.2016, Order-in-Original No. 262 of 2016 dated 04.03.2016 and Order-in-Original No. 263 of 2016 dated 04.03.2016
- 3. This office has issued several notices to your address for necessary compliance of the lawful liability but neither you e-filed monthly Sindh sales tax returns as required nor deposited Government dues. This is the serious violation of the above referred statutory provisions of the Act, 2011 and the Rules made thereunder.
- 4. Now, this notice is being issued to you under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No. 02 of 2013 and Rule 10 of the Sindh Sales Tax on Service Rules, 2011 to the effect that your registration is hereby suspended with immediate effect. However, your suspension shall be revoked if you take the following remedial actions by April 30, 2016;

- to e-file the true and correct monthly Sindh sales tax returns (Form SST-03) for the tax periods January-2015 to February-2016
- to deposit Government dues of Rs 180,000/- in the Government of Sindh's Head of Account "B-02384"
- 5. In case of non-satisfactory response or failure to take remedial measures suggested above on or before **30.04.2016**, your case shall be further proceeded for cancellation of your registration with SRB.
- 6. This notice and suspension of registration are without prejudice to the penal action, prosecution action and recovery action as may be taken against M/s. M. Farrukh Associates, in accordance with the provision of the Act and the Rules.
