Whereas, M/s Pranzo Restaurant & Cafe (here-in-after referred to as the registered person) bearing SNTN# S2573958-1 is registered under the principal activity of "Services provided or rendered by Restaurant" under tariff heading (9801.2000) as specified in Schedule-II of the Sindh Sales Tax on Services Act, 2011 (here-in-after referred to as the Act-2011). The registered person is liable to charge, collect and deposit the Sindh sales tax on services as per the provision of Section 3, 8, 9 & 17 of the Act, 2011 read with rule 42 of the Sindh Sales Tax on Services Rules, 2011 (the "Rules, 2011"). Whereas, the registered person is also required to e-file monthly Sindh sales tax return in the light of the provision of section 30 of the Act, 2011.

- This office sealed the business premise of the registered person vide Order-in-Original No. 680 of 2022, dated 31.03.2022, Order-in-Original No. 495 of 2022, dated 09.03.2022, Order-in-Original No. 511 of 2022, dated 11.03.2022 and notice No. SRB/COM-1/AC-02/2021-22/131362, on 13<sup>th</sup> May, 2022. The registered person was directed to immediately comply with the provisions of Sindh Sales Tax on Services Act, 2011 and the rules made thereunder.

Whereas, the registered person has paid Sindh sales tax (SST) amounting to **Rs. 2,500,000/**-vide CPR No. S1-20220518-1027-1230321, dated: 18.05.2022 and have also submitted a cheque No. 2446741272 amounting to **Rs. 2,500,000/-** (copy reproduced hereunder) dated 24/06/2022, out of their total liability of **Rs. 9,110,434/-**
- 04. The registered person has further undertaken to:
  - (i) Deposit remaining Tax liability by December, 2022.
  - (ii) Deposit the amount of SST due every month and file true and correct monthly SST returns in light of section 30 of the Act 2011.
  - (iii) Issue proper invoices in strict compliance to Rule 29(1) of the Rules, 2011.
  - (iv) Ensure POS integration at the earliest.
  - (v) Add all business branches in their SRB Tax profile.
  - (vi) Comply with the provisions of Sindh Sales Tax on Services Act, 2011 and the rules made thereunder.
