**ORDER FOR REVOCATION OF SUSPENSION OF
M/s. PIPELINK CONSTRUCTION (PRIVATE) LIMITED**

Name & NTN of Person Suspended:	Pipelink Construction (Private) Limited SNTN: S1298048-0
Address:	Suite No.12, 2 nd Floor, Hilltop Arcade, Gizri Boulevard, Phase IV, DHA, Defence Housing Authority, Karachi
Reason for Suspension	Non-compliance of the provisions of sections 3, 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder

Whereas, M/s. Pipelink Construction (Private) Limited (*hereinafter to be referred as 'the registered person'*) having SNTN: S1298048-0 are registered with Sindh Revenue Board under the category of "Contractual execution of works or furnishing supplies" classified under tariff heading 9809.0000 of the Schedule-II of Sindh Sales Tax on Services Act, 2011 (*hereinafter to be referred as 'the 2011-Act'*).

02. Scrutiny of tax profile revealed that they have failed to deposit the SST amount of **Rs.4,605,548/-** as required under section 9 and 17 of the 2011-Act read-with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (*hereinafter referred to as 'the 2011-Rules'*). Moreover, the registered person has also failed to e-file the correct SST returns as required under Section 30 read with Rule 11, 12, 13 and 14 of the said Rules, 2011.

03. The advocate of the registered person requested this office to restore Sindh sales tax registration number S1298048-0 from suspended units list, though its letter No.Nil dated 12th April, 2021 along-with a cheque No. 2444673492 dated 10th April, 2021 total amounting to **Rs.2,302,774/-** (*Rupees Two Million Three Hundred and Two Thousand Seven Hundred Seventy Four Only*) withdraw/issue from his bank account No. **0010004403480025** maintained in Allied Bank Limited, Defence Housing Authority, Gizri Road, DHA Phase-IV, Karachi, in favour of "Sindh Revenue Board". He further undertakes that, they shall reconcile their record with their clients within 15 days and will pay all remaining due tax after such reconciliation.

I have gone through the submission of the Advocate of M/s Pipelink Constructions (Private) Limited and concluded that, due to suspension of registration the complete tax profile of registered person is blocked on *i.srb* portal, resultantly, the taxpayer neither can e-file the return nor can generate the PSID on its NTN. Therefore, taking a lenient view and for purpose of carrying on their business activity and subsequent remedial actions to be taken by the registered person and till the reconciliation of the records, this office notice/order dated 1st April, 2021, the suspension of the registered person is hereby **revoked with immediate effect**, subject to fulfil the following conditions and limitations within fifteen (15) days of restoration of this Order and also remained compliant of the provisions of the Sindh Sales Tax on Services Act, 2011 and Rules made thereunder :-

- i. to file true and correct all pending Sindh sales tax returns;*
- ii. to deposit the remaining due SST amount within fifteen days from this Order, if any;*
- iii. to submit the copies of annual audited accounts for the FY 2019-20 and 2020-21; and*
- iv. any other document/record, if required in later stage by the Department for reconciliation.*
