**ORDER FOR RESTORATION OF SUSPENSION OF  
M/s IZ INDUSTRIAL SERVICES**

Name & NTN of Person Suspended:	M/s. IZB INDUSTRIAL SERVICES (SNTN#1439005-1)

Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods:	December, 2015 to February, 2019

Whereas, M/s. IZB INDUSTRIAL SERVICES having SNTN: 1439005-1 are registered with Sindh Revenue Board under the category of "Construction Services" classified under tariff heading 9824.0000 to the second schedule of Sindh Sales Tax on Services Act, 2011 (hereinafter "Act, 2011")

2. Scrutiny of tax profile revealed that they have failed to deposit the SST amount as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as "the Act, 2011") read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the Rules, 2011") and failed to e-file the SST returns as required under Section 30 read with Rule 11,12,13 and 14 of the said Rules, 2011 pertaining to the tax periods December, 2014 to June, 2017.

3. Accordingly, notice bearing NO. SRB-COM-I/Unit-3/2018/3919 dated 17<sup>th</sup> April, 2019 was served upon the registered person under section 25 of the Act, 2011 read with Circular No. 02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of M/s. IZB INDUSTRIAL SERVICES was suspended for the violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provision of the Act, 2011 and the rules made thereunder before 21<sup>st</sup> May, 2018, failing to which the case shall be proceeded for cancellation of registration.

4. On 7<sup>th</sup> May, 2019, Mr.Nazir Hyder from M/s Aziz Ismail & Co. appeared before the undersigned and submitted letter vide reference No.IZB INDUSTRIAL SERVICES/SRB/2018-19 wherein they submitted that the matter was under reconciliation at their part. Moreover, they stated that there was duplication of Invoices amounting to Rs.3,220,100/- in the Annex-A of their service recipients.

5. Furthermore, they also stated that Rs.1, 137,100/- has already been deposited by them vide CPR No. S1-20160907-0255-1035288, S1-20161014-0282-1104662, S1-20161117-1063-1170843. Besides, they have committed to deposit the SST amount to the value of Rs.1,040,158/- into the

Sindh Government's head of Account "B-02384" in the prescribed manner along with penalty and default surcharge in May, 2019. However, remaining reconciliation is underway against which Show cause notice has already been issued.

6. Now, M/s IZB Industrial Services are required to submit the final reconciliation on 17-05-2019 and deposit the due SST amount into Sindh Government's head of Account "B-02384" as per their commitment.

7. I have heard the representatives of M/s. IZB Industrial Services and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN. Since, M/s. IZB Industrial Services has undertaken to reconcile the data till the next date of hearing which is fixed on **17-05-2019**. Therefore, taking a lenient view and for purpose of carrying on their business activity and subsequent remedial actions to be taken by the registered person, this office notice dated 17-04-2019, the suspension of the registered person is hereby **revoked with immediate effect**. In case of failing to fulfilment of stated remedial actions, registration of taxpayer may be subject to suspension again.
