ORDER FOR REVOCATION OF SUSPENSION OF REGISTRATION

Name & NTN of Person Suspended:	M/s Argus Advertising (Private) Limited, NTN-1519064-1
Address:	C-11 Block 4 Clifton, Karachi.
Date of Suspension:	September 08, 2020
Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder

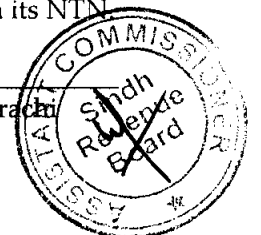
Brief facts of the case are that M/s Argus Advertising (Private) Limited (hereinafter referred to as "registered person") bearing SNTN No. 1519064-1 are registered with SRB under the service category of Advertising Agents which are chargeable to the Sindh Sales Tax ("SST") under section 8 read with tariff heading 9805.7000. The persons registered for Sindh Sales Tax on Services under section 24, 24A or 24B are required to e-file true and correct monthly sales tax returns under section 30 of the Sindh Sales Tax on Services (hereinafter referred to as "the Act, 2011") read with rule 13 & 33 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the Rules, 2011"). Moreover the person is also required to deposit due SST amount payable on rendering or providing the taxable services in Sindh in terms of section 3, 4,5,8,9 and 17 of the Act, 2011 read with the Rules, 2011.

2. Scrutiny of online record revealed that the aforementioned person failed to deposit the SST amount as required under section 9 and 17 of the Act, 2011 read with rule 14 of the Rules, 2011.

3. Accordingly, this office letter bearing NO.SRB-Com-III/AC-19/Adv.Agent/2016/21/17471 dated 24-08-2020 regarding suspension of registration was served upon the registered person under section 25 of the Act, 2011, read with Circular no. 02 of 2013 and rule 10 of the Rules, 2011, as to why their registration of Sindh Revenue Board may not be suspended for violation of the provisions of the Act, 2011 read with Rules, 2011, till the remedial action shall not be taken by them on or before 07-09- 2020.

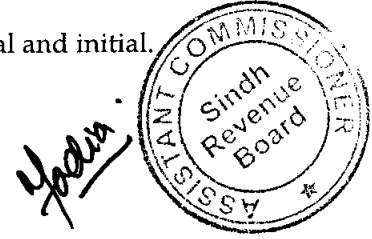
4. In reply, the representative of the registered person appeared for hearing on 11-09-2020. He submitted a reply in writing and provided record of their business for reconciliation to this office on 14-09-2020. Therefore, the matter is under reconciliation.

5. I have heard the representatives of the M/s Argus Advertising (Private) Limited and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of the registered person is blocked on i.srb portal due to which the registered person can neither e-file the return nor can generate the PSID on its NTN.



Therefore, taking a lenient view and for the purpose of carrying on their business activity and subsequent remedial actions (if any) to be taken by the registered person after the reconciliation of the records, the suspension of the registered person is hereby revoked with immediate effect. In case of failure to fulfillment of stated remedial actions (if any), the registration of the registered person may be subject to suspension.
