ORDER FOR WITHDRAWAL OF SUSPENSION

BRIEF FACTS OF THE CASE:

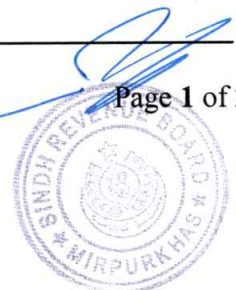
Whereas, M/s Mashooque Ali Magsi Govt. Contractor, having SNTN: S2610163-7, (here-in-after referred as 'the Registered Person'), are registered for Sindh sales tax on services, under the service category of "Contraction Services (tariff heading 9824.0000)" and all the person registered for the Sindh Sales Tax on Services under section 24, 24A or 24B are required to e-file true and correct monthly sales tax returns under section 30 of the Sindh Sales Tax on Services Act, 2011 (hereinafter "the Act, 2011") read with rule 13 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter "the Rules, 2011"), for the tax period by the 18th day of the month following the tax period to which it relates. Moreover, the person is also required to deposit due SST amount payable on rendering or providing taxable services in Sindh province, in terms of section 8, 9 and 17 of the Act, 2011 read with rule 14 of the Rules, 2011.

02. Scrutiny of the online SRB profile of the registered person showed that the registered person did not e-file monthly SST returns for the tax periods December, 2016 to June, 2017, which is serious violation of section 30 of the Act, 2011 and rules made thereunder.

03. Accordingly, a notice was served upon the registered person under section 25 of the Act, 2011, read with the circular No. 02 of 2013 and rule 10 of the Rules, 2011, whereby, the registration of M/s Mashooque Ali Magsi Govt. Contractor was suspended for violation of above mentioned statutory provisions of the Act, 2011. Moreover, the registered person was required to comply with relevant provisions of Act, 2011 and rules made thereunder by e-filing of SST returns, failing to which the case was to further proceed for cancellation of registration.

04. The owner of M/s Mashooque Ali Magsi Govt. Contractor, Mr. Mashooque Ali Magsi submitted vide letter No. Nil dated Nil received on March 16, 2021, requested to restore the SRB registration, along-with copy of CPR and CNIC. Wherein, he submitted that in future, no default shall be made for filing of monthly SST returns and admitted his default for e-filing monthly sales tax returns for the tax periods December, 2016 to June, 2017. The registered person also realized the mistake and committed to e-file all sales tax returns for the aforesaid tax periods, as required under section 30 of the Act, 2011. In this regard, the registered person deposited penalty amount vide CPR No. S1-20210308-0050-1216515 dated 08-03-2021 for non-filing of monthly sales tax returns. He further assured that he would not repeat his default in future and shall pay all dues of the Sindh sales tax including penalties and short payments if any found and as communicated by this office.

05. In view of the foregoing position, the SRB registration of M/s Mashooque Ali Magsi Govt. Contractor, holding SNTN: S2610163-7, may be restored with immediate effect, under intimation to the undersigned, so that the taxpayer may be able to e-file his due Sindh sales tax returns and pay the due SST amount in the normal course henceforth.

06. Furthermore, M/s Mashooque Ali Magsi Govt. Contractor is required to e-file their monthly sales tax returns for the tax periods December, 2016 to January, 2021 after restoration of their suspended registration, *immediately*.
