NOTICE FOR SUSPENSION OF REGISTRATION OF M/S. AL- KHALID AGENCIES FOR WASTE MANAGEMENT (SNTN: S2141300-2).

Whereas, section 25(1) (a) (ii) of the Sindh Sales Tax on Services Act, 2011 hereinafter "Act, 2011" provides that registration of a registered person can be suspended where registered person "has failed to comply) with its obligations under this Act". Rule 10 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter "Rules, 2011") also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax, the Board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

02. Whereas, scrutiny of withholding CPR statement of M/s. **Sindh Solid Waste Management Board** reveals that M/s. Al-Khalid Agencies for Waste Management, have provided taxable services of "Janitorial Services" involving Sindh Sales Tax amounting to **Rs.1,772,236/-.** Detailed breakup is given below in Table -I:

03. In the view above it is clear that you have declared wrong and false SST returns which exclusively comes under the ambit of tax fraud defined in section 2(94)(c) of the Act, 2011 pertaining to the said tax periods, now you are required to **revise your SST return** and immediately pay/deposit the Sindh sales tax amounting **Rs.1,772, 236**/-



Now, this notice is being issued to you under section 25 of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Rules, 2011 to the effect that your registration is hereby suspended with immediate effect. However, your suspension shall be revoked if you take following remedial actions by 24th May 2018;

- To discharge your sales tax liabilities of Rs. 1,772, 236/- along with default surcharge under section 44 of the Act, 2011 for aforementioned tax periods and deposit the same in the Government of Sindh head of account B-02384.
- To revise your Sindh sales tax returns and e-file true and correct monthly Sindh sales tax returns (Form SST-03) for the said tax periods.
- 05. In case of non-satisfactory response or failure to take remedial measures as suggested above on or before 24th May, 2018, your case shall be further proceeded for cancellation of your registration with SRB.
- O6. This notice and suspension of registration are without prejudice to the penal action, prosecution action and recovery action as may be taken against M/s Al- Khalid Agencies for Waste Management in accordance with the provisions of the Act or the Rules.
