Subject: **RESTORATION ORDER — M/S FARAN CONTRACTORS (NADEEM AKHTAR) HAVING SNTN # 2939147**

Reference may kindly be made to the letter NO.SRB/COM-SUK/COB-57/Faran.Nadeem/2021/1250 dated 31-05-2021 whereby the SRB registration of above registered person was suspended in terms of Section 25(1)(a)(i) of Sindh Sales Tax on Services Act, 2011 and Rules made thereunder.

2. Learned advocate, Mian Aziz-ur-Rehman appeared on behalf of registered person. He presented newspaper dated 15-2-2021 (Awami Awaz) wherein he highlighted that the owner/registered person has terminated his supervisor who was looking after all tax matter and who has conducted frauds in books of accounts. He submitted that his client is law-abiding citizen and agreed with short payment of SST, however, he is unable to pay off dues in on go. He presented payorder of Rs.100,000/- and requested for three equal instalments of remaining SST of Rs.10,99,924/- and further requested to restore their registration.

3. Request considered. He is directed to deposit outstanding SST dues of Rs.10,99,924/- into three equal monthly instalments of **Rs.366,642/- each month on 20th of every month with first instalment to start from January 2022.** Besides this, registered person shall make sure to deposit regular monthly Sindh sales tax and e-file monthly returns. In case of non-compliance to above directions, necessary action shall be taken as per law.
