**ORDER FOR WITHDRAWAL OF SUSPENSION**


**BRIEF FACTS OF THE CASE:**

M/s My Choice, holding NTN: 7152144-6, are registered for Sindh sales tax on services under the service category of "Contractor of Building (tariff heading 9814.2000)". The persons registered for Sindh Sales Tax on Services under section 24, 24A or 24B are required to e-file true and correct monthly sales tax returns under section 30 of the Sindh Sales Tax on Services Act, 2011 (hereinafter "the Act, 2011") read with rule 13 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter "the Rules, 2011"), for the tax period by the 18th day of the month following the tax period to which it relates. Moreover, the person is also required to deposit due SST amount payable on rendering or providing taxable services in Sindh province in terms of section 3, 4, 5, 8, 9 and 17 of the Act, 2011 read with rule 14 of the Rules, 2011.

02. Scrutiny of the online record of SRB showed that the aforesaid person did not e-file monthly sales tax return for the tax periods March, 2017, April, 2017, May, 2017 and June, 2017, which is in violation of section 30 of the Act, 2011 and rules made thereunder.

03. Accordingly, office letter bearing No.SRB-COM-II/DC-13/Suspension Order/01/17-18/237571 dated 25.07.2017 was shared with the request to place their SRB registration under suspension in terms of Section 25(1)(a)(ii) of the Act, 2011 and the Rules made thereunder.

04. The registered person appeared for hearing on 19.05.2021. He admitted his default on e-filing monthly sales tax returns and request for revocation of suspension order. The said person has realized the mistake and committed to e-filing all sales tax returns as required under section 30 of the Act, 2011. In this regard, the said person has deposited penalty amount of Rs.10,000/-, vide CPR No. S12021020100361016398 dated 01.02.2021, for non-filing of monthly sales tax returns and has assured that he will deposit remaining penalty amount of Rs.40,000/- by 05.06.2021. He further added that he will also clear his SST

liability of Rs.360,000/- by 15.06.2021, without fail. The said has also assured that he would not repeat his default in future.

05. In view of above, the SRB registration of M/s My Choice, holding NTN: 7152144-6, is hereby restored with immediate effect, so that the taxpayer may be able to e-file his due Sindh sales tax returns and pay the due amount of Sindh sales tax in the normal course henceforth.

06. M/s My Choice are required to immediately e-file their monthly sales tax returns for the aforesaid tax period after restoration of their suspended registration. He is also required to clear all his arrears of penalty & taxes within 15 days from this order.

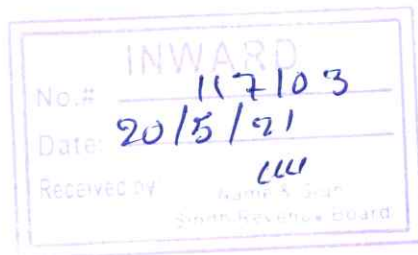
