- Now, this notice is being issued to you under section 25 of the Act, 2011 read with 4. However, your suspension shall be revoked if you take following remedial action by 27th June, 2019; to e-file the true and correct monthly Sindh sales tax returns (Form SST-03) for the said tax periods.
- In case of non-satisfactory response or failure to take remedial measures as suggested above on or before 27th June, 2019, your case shall be further proceeding for cancellation/deregistration of your registration with SRB.
