
(Sindh Sales Tax on Services)

Notification No.SRB-3-4/6/2012.-----In exercise of the powers conferred by clause (m) of sub-section (1) of section 4 of Sindh Revenue Board Act, 2010 (Sindh Act No. XI of 2010), and sections 34 and 35 of Sindh Sales Tax on Services Act, 2011 (Sindh Act No. XII of 2011), the Sindh Revenue Board is pleased to authorize the officers of the SRB, specified in column (2) of the table below, to exercise the powers and discharge the functions and duties specified in column (3) of the table below in relation to any case falling under the provisions of the Sindh Sales Tax on Services Act, 2011: -

1	Commissioner, Survey and Intelligence, Sindh Revenue Board	<ol style="list-style-type: none">1. Field survey, including survey of registered and un-registered taxpayers.2. Identifying potential taxpayers and persons liable to registration/compulsory registration action.3. Ascertaining quantum of sales tax evaded by any registered or un-registered person and preparation of contravention report for finalization of assessment and adjudication proceedings by the Operations Wing of SRB.4. Detection of cases of non-payments, short-payments and tax frauds.5. Information gathering and Intelligence & investigation in pursuance of the information.6. Detection of cases of offences liable to prosecution under the Act and assisting Legal Wing of SRB in preparation of FIR and Challan and in departmental representation of such

		<p>cases in the court/adjudication/apellate forums.</p> <p>7. Exercising the powers under sections 27(2), 28, 36(2), 48, 49, 50, 51, 52, 53 and 70 of the Sindh Sales Tax on Services Act, 2011.</p> <p>8. Any other task or function as may be assigned or entrusted by the Board.</p>
2	Deputy Commissioner, Survey & Intelligence, Sindh Revenue Board, and Assistant Commissioner, Survey & Intelligence, Sindh Revenue Board	<p>Powers and Functions as may be delegated and assigned by the Commissioner, Survey & Intelligence, Sindh Revenue Board within his jurisdiction. The Deputy Commissioner and the Assistant Commissioner, Survey and Intelligence, Sindh Revenue Board, shall also be authorized to issue notices for registration, including compulsory registration, to the un-registered persons and obtain necessary compliance. The non-compliant persons shall be reported to the Operations Wing of SRB alongwith contravention report.</p>
