ORDER FOR REVOCATION OF SUSPENSION OF
M/S. ISLAM KHAN & COMPANY

Name & NTN of Person Suspended:	M/s. Islam Khan & Company SNTN: S3948920-5
Address:	Islam Khan Ice Factory, Kori Khooh, Main Road, Mirpur Mathelo.
Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder.

M/s. Islam Khan & Company (hereinafter referred to as the 'registered person'), having SNTN: S3948920-5 are engaged in providing or rendering the services of Labour and Manpower Supply Services classified under tariff heading 9829.0000 of the Second Schedule to the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as the "Act, 2011").

2. Whereas, scrutiny of tax profile of the registered person as maintained with Sindh Revenue Board transpire that the said company has failed to deposit the Sindh Sales Tax ('SST') amount of **Rs.6,123,052/-** and also failed to e-file the correct SST returns for the tax periods from **December-2017 to February-2021** as required under Section 30 read with Rule 11, 12, 13 and 14 of the said Rules, 2011.

3. The notice for suspension vide No. SRB-COM-SUK/AC-33/L&MP-16/2021/721 dated 13th April, 2021 was served upon the company under section 25 of the Act, 2011 read with Circular No. 02 of 2013 and Rule 10 of the Rules, 2011 whereby M/s. Islam Khan & Company was suspended for non-payment of Sindh Sales Tax and non-filing of returns including the violation of aforesaid provisions of law. Moreover, the company was required to comply with the said provision of the Act, 2011 and the rules made thereunder, failing to which the case shall be proceeded for cancelation of the registration with Sindh Revenue Board.

4. On 21st April, 2021, Mr. Islam Khan, owner of the above registered person appeared in relation to suspension of registration order dated 13.04.2021. He contended that he has already made the payment of Sindh sales tax and he is willing to reconcile the same. He placed on record the cheque of Rs.500,000/- and for the remaining amount of **Rs.5,623,052/-**, he requested for time of twenty days to come up with reconciliation and agreed to deposit the due amount of tax after reconciliation. He requested that the suspension may be revoked in other case, he would be seriously prejudiced.

5. Keeping in view the above submissions, the company has requested to restore their registration with SRB so that they could be able to file their Sindh sales tax returns and deposit the due sales tax liabilities as currently the SRB online portal does not allow both the activities. As a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of



registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN. Therefore, considering their request, Mr. Islam Khan is hereby given time till **11th May, 2021** for reconciliation of the remaining liability.

6. Keeping in view the above, the suspension of the registered person is hereby **revoked with immediate effect**. In case of failure to the above-stated actions, the case shall be further proceeded for suspension and cancellation of your registration with SRB.
