| Tax Periods: | October-2015 to January-2018 |

Brief facts of the case are that M/s E-Ocean (Private) Limited bearing SNTN No. S3113043-7 are registered with SRB as a service provider in respect of telecommunication services which are chargeable to the Sindh Sales Tax ("SST") under section 8 read with tariff heading 98:12 and sub-tariff heading thereof.

2. Scrutiny of their tax profile revealed that they failed to deposit the SST amount as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as "the 2011-Act") read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the 2011-Rules") and failed to e-file the SST returns as required under section 30 read with Rule 11, 12, 13 and 14 of the said Rules-2011 pertaining to the tax periods from October-2015 to January-2018.

3. Accordingly, notice bearing No. SRB/Com-I/AC-1/TEL/Ocean/21/2013/5829 dated 20-2-2018 was served upon the registered person under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011 whereby the registration of M/s E-Ocean (Private) Limited was suspended for violation of aforesaid provisions of the law. Moreover, the registered person was were required to comply with the said provisions of the Act-2011 and the Rules made thereunder failing to which the case shall be proceeded for cancellation of registration.

4. On 21-5-2018, Mr. Asif Iqbal, Head of Finance & Taxation, M/s E Ocean (Private) Limited submitted undertaking along with photocopies of payorder No. 00002313 dated 16-5-2018 amounting to Rs.3,547,370/- on account of principal amount of tax and another cheque No. 23574758 dated 21-5-2018 amounting to Rs. 201,469/- on account of default surcharge (being the 5% of total amount of default surcharge) under section 44 of the Act-2011 in terms of SRB notification No.SRB-3-4/11/2018 Dated 18th May, 2018.

5. Mr. Asif Iqbal, Head of Finance & Taxation, M/s E Ocean (Private) Limited requested to restore the registration so as they can generate the PSID, deposit the tax amount.

6. I have heard the representative of M/s E Ocean (Private) Limited and came to the conclusion that, as a matter of procedure, on suspension of registration of



taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN. Since M/s E-Ocean (Private) Limited has assured of discharging their tax liability, therefore, taking a lenient view and for purpose of carrying on their business activity and to take the remedial action provided in this office notice dated 20-2-2018, the suspension of registration is hereby **revoked with immediate effect**.

7. M/s E-Ocean (Private) Limited are required to:
- generate PSID against said payorder/cheque immediately on restoration of registration,
 - deposit the aforesaid payorder/cheque immediately upon revocation of suspension,
 - deposit the tax amount, if any, and e-file SST returns within one week for the tax periods from **October-2015 to January-2018** after revocation of suspension.
 - Update their Sindh sales tax particulars such as change of name, business address etc. within one week of revocation of suspension.
