ORDER FOR REVOCATION OF SUSPENSION

Name & NTN of Person Suspended:	M/s E Ocean (Private) Limited, SNTN-S4359280-5
Address:	Mezzanine Floor, Building No. 29-C, Sunset Lane-I, Phase- II Extension, D.H.A, Karachi.
Date of Institution:	16-5-2018
Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods:	February-2018 to April-2018

Brief facts of the case are that M/s E Ocean (Private) Limited bearing SNTN No. S4359280-5 are registered with SRB as a service provider in respect of telecommunication services which are chargeable to the Sindh Sales Tax ("SST") under section 8 read with tariff heading 98:12 and sub-tariff heading thereof.

- 2. Scrutiny of their tax profile revealed that they failed to deposit the SST amount as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as "the 2011-Act") read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the 2011-Rules") and failed to e-file the SST returns as required under section 30 read with Rule 11, 12, 13 and 14 of the said Rules-2011 pertaining to the tax periods from February-2018 to April-2018.
- 3. Accordingly, notice bearing SRB-Com-I/AC-1/TEL/EOcean/2018/V-69/6068 dated 16-5-2018 was served upon the registered person under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011 whereby the registration of M/s E Ocean (Private) Limited was suspended for violation of aforesaid provisions of the law. Moreover, the registered person was were required to comply with the said provisions of the Act-2011 and the Rules made thereunder failing to which the case shall be proceeded for cancellation of registration.
- 4. On 21-5-2018, Mr. Asif Iqbal, Head of Finance & Taxation, M/s E Ocean (Private) Limited submitted undertaking along with photocopies of cheque No(s). 23574744, 23574738 & 23574745, dated 15-5-2018, 15-5-2018 & 16-05-2018 amounting to Rs. 1,329,722/-, Rs. 1,056,286/- & 834,076/- respectively on account of principal amount of SST for the tax period(s) from February-2018 to April-2018.
- 5. Mr. Asif Iqbal, Head of Finance & Taxation, M/s E Ocean (Private) Limited requested to restore the registration so as they can generate the PSID, deposit the amount.
- 6. I have heard the representative of M/s E Ocean (Private) Limited and came to the conclusion that, as a matter of procedure, on suspension of registration taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN.

Since M/s E Ocean (Private) Limited has provided original cheques, therefore, taking a lenient view and for purpose of carrying on their business activity and to take the remedial action provided in this office notice dated 16-5-2018, the suspension of registration is hereby revoked with immediate effect.

- M/s E Ocean (Private) Limited are required to: 7.
 - a) generate PSID against said cheques immediately on restoration of registration,
 - b) e-file the returns within 2 days of deposit of tax amount,
 - c) deposit the tax amount and e-file the tax returns in the time and manner prescribed under the provisions of the Act-2011 and the Rules made thereunder going forward.
 - d) deposit the default surcharge amounting to Rs.2,476/- (being 5% of total default surcharge) in terms of SRB notification No.SRB-3-4/11/2018 dated 18th May, 2018 on or before 27-5-2018.
