SUBJECT: REVOCATION OF SUSPENSION OF M/S. M-Y-H-C CONSTRUCTION COMPANY (SNTN: S3188716)

Kindly refer to this office earlier letter of even No.SRB-COM-II/AC-03/Cons/2018-19/2065, dated 31.10.2018, on the subject matter, whereby, notice for suspension was served upon the registered person under section 25 of the Act, 2011 read with Circular No. 02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of M/s. M-Y-H-C CONSTRUCTION COMPANY were suspended for the violation of section 30 of the Act, 2011, read with rule 12 of the Sindh Sales Tax on Services Rules, 2011. Moreover, the registered person also failed to make payment of Sindh sales tax on services as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011, read with rule 14 of the Sindh Sales Tax on Services Rules, 2011, to the value of Rs.1,647,929/- since their registration.

02. On 20<sup>th</sup> November, 2019, the registered person submitted a request for restoration of their registration and stated that their 100% sales tax was withheld and deposited by service recipients. Moreover, they also submitted the copies of CPRs for the reconciliation of the short paid sales tax amount and admitted that they would deposit the short paid SST amount if it emerges out after the reconciliation of record. They made commitment to provide every record for the purpose of reconciliation. However, in future company would ensure complete compliance to SST Act, 2011 and accordingly to rules made therein.

03. In view of the foregoing position, it is requested that the SRB registration of the below listed taxpayer, may be restored on with immediate effect, under intimation to the undersigned, so that henceforth, the taxpayer may be able to file their due Sindh sales tax returns and pay the due amount of Sindh sales tax in the normal course.
