ORDER FOR REVOCATION OF SUSPENSION

Name & NTN of Person Suspended:	M/S. H2 Ready Mix (Private) Limited (SNTN: 4109930-3)
Address:	Room # 404, 4 th Floor, The Square, Shaheed Millat Road, Bahaduarabad, Karachi
Date of Institution:	11 th Jan, 2023
Reason for Suspension	Non-compliance of the provision of section 9, 17 & 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods:	Apr-2022 to Nov-2022

Whereas, M/s. H2 Reay Mix (Private) Limited are registered with Sindh Revenue Board having SNTN: 4109930-3, are engaged in providing or rendering taxable services of 'Ready Mix Concrete Services' under the tariff heading '9837.0000'.

2. Scrutiny of their tax profile revealed that they have failed to deposit due Sindh sales tax for the tax periods from Jul, 2022 to Nov, 2022 and also failed file their monthly Sindh sales tax returns for the tax period **Apr-2022 to Nov-2022** as required under section 9, 17 & 30 of the Act, 2011 read with Rule 11, 12, 13 and 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the Rules, 2011").

3. Accordingly, order of suspension of the registration vide reference NO.SRB-COM-IV/UNIT-03/2023/117259 dated 11th Jan, 2023 was served upon the registered person under section 25 of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of M/s H2 Ready Mix (Private) Limited was suspended for violation of aforesaid provision of the law.

4. Subsequently, they appeared multiple times and thereby paid the Voluntarily Sindh Sales Tax amount of Rs.4,420,049 alongwith default surcharge to the tune of Rs.419,841/-. Also, they assured this office that they would fully comply with the provisions of the Sindh Sales Tax. They also assured full compliance regarding filing of their regular monthly Sindh sales tax return on due date and time in future. Working of their SST payments and Default Surcharge is given below:

5. Besides, aforesaid payments, M/s H2 Ready Mix (Private) Limited through letter dated 17/03/2023 has also under taken to pay any other liability (if arisen in the future). It is to add here that as they have voluntarily pay the Sindh Sales Tax liability alongwith default surcharge and the suspension of registration does not allow the registered person to make the PSIDS and file the regular returns of SST. Therefore, taking a lenient view and for purpose of carrying on their business activity as well as subsequent remedial actions to be taken by the registered person, the

suspension of the registered person is hereby revoked with immediate effect. Registered person is directed, after revocation of suspension, to immediately e-file the monthly Sindh Sales Tax Returns and deposit the Sindh Sales Tax along with default surcharge in terms of sections 8, 9, 17, 30 and 44 of the Act-2011 read with Rule 11, 12, 13 and 14 of the Rules-2011 failing which necessary action including imposition of penalties and re-suspension of their registration shall be initiated as per law. Please note that the returns filed by the registered person will be subjected to assessment under the relevant provisions of the Act-2011.
