ORDER FOR REVOCATION OF SUSPENSION

Brief facts of the case are that M/s. Cyber Tracking Solutions (Pvt) Limited bearing SNTN No. 2981215-1 are registered with SRB as a service provider in respect of telecommunication including vehicle & other tracking services which are chargeable to the Sindh Sales Tax ("SST") under section 8 read with tariff heading 98:12 and subtariff heading thereof.

- 2. Scrutiny of their tax profile revealed that they failed to deposit the SST amount as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as "the 2011-Act") read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the 2011-Rules") and failed to e-file the SST returns as required under section 30 read with Rule 11, 12, 13 and 14 of the said Rules-2011 pertaining to the tax periods December-2013 to May-2017 and August-2017 to May-2018.
- 3. Accordingly, notice bearing SRB-Com-I/AC-1/Tracking/Cyber Track/2017/V-22/6185 dated 1-6-2018 was served upon the registered person under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011 whereby the registration of M/s. Cyber Tracking Solutions (Pvt) Limited was suspended for violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provisions of the Act-2011 and the Rules made thereunder before 15-6-2018 failing to which the case shall be proceeded for cancellation of registration.
- 4. Mr. Bahadur Aurora, on behalf of M/s. Cyber Tracking Solutions (Pvt) Limited appeared on 20-6-2018 and submitted five original payorders on account of partial SST liability for the following tax periods:

- 5. Mr. Bahadur further stated that company is suffering financial distress and is unable to deposit whole amount in one-go, however, he is depositing the partial tax amount. He further undertakes to deposit the tax for remaining tax periods. Accordingly, he requested to restore the registration so that he could deposit SST payment and e-file monthly SST returns for the periods thereof.
- Limited and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN. Since M/s. Cyber Tracking Solutions (Pvt) Limited has provided original payorders, therefore, taking a lenient view, to partially discharge SST liability, the suspension of the registered person is hereby **revoked with immediate effect**.
- 7. M/s. Cyber Tracking Solutions (Pvt) Limited are required to:
 - a) generate PSID against said payorders immediately on restoration of registration,
 - b) e-file the returns within 2 days of deposit of tax amount for aforesaid months,
 - c) deposit the default surcharge of Rs.1,150/- (being 20% of total default surcharge of Rs.5,751/-) in terms of SRB notification No.SRB-3-4/11/2018 dated 18th May, 2018 **on or before 30-6-2018**.
 - d) deposit the tax amount and e-file the returns for remaining tax periods on or before 09-07-2018.
