**ORDER FOR REVOCATION OF SUSPENSION**

**Brief facts of the case:**

**M/s. Muhammad Asif Govt. Contractor** bearing SNTN#0249101-0 are registered with SRB (the "registered person") under the principal service category of "Services provided or rendered by persons engaged in contractual execution of work or furnishing supplies" covered under tariff heading 9809.0000 of the Second Schedule to the Sindh Sales Tax on Services Act, 2011 (the "Act, 2011"). The registered person was required to comply with the provisions of section 3, 8, 9, 17 & 30 of the Act, 2011 read with relevant rules of Sindh Sales Tax on Services Rule, 2011 (the "Rules, 2011").

**02.** The SRB registration of **M/s. Muhammad Asif Govt. Contractor** was suspended vide SRB general suspension order bearing Ref:NO.SRB-COM-II/DC-13/Suspension Order/01/17-18/237571 dated 25.07.2017 issued under section 25 of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011. The SRB registration was suspended on account of non-filing of monthly Sindh sales tax returns for the tax periods March, 2017, April, 2017, May, 2017 and June, 2017.

**03.** Whereas, M/s Muhammad Asif Govt. Contractor requested for restoration of SRB registration vide letter No. Nil, dated: 11-11-2021 (received on 15.11.2021), the registered person stated that, he did not receive any notice from the department about his suspension and he has just come to know that the SRB profile is blocked and therefore he wanted to get his account activated and e-file SST monthly returns and will deposit the due tax accordingly. Further, the registered person paid the penalty amounting to Rs.30,000/- and produced the copy of CPR#S1-

04. I have examined the facts & circumstances of the case and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on e/i.srb portal, due to which the taxpayer neither can e-file the return nor can generate the PSID on their own SNTN. Since, the M/s. Muhammad Asif Govt. Contractor have assured for full compliance of the provisions of the Act-2011 and rules made thereunder. Therefore, taking lenient view and for purpose of carrying on their business activity and to e-file monthly SST returns and make due tax payments, the suspension of the registered person as per the provision of section 25(4) of the Act, 2011 is hereby **revoked with immediate effect**.

05. This order is without prejudice to any other action under the law for the time being in force. Therefore, the penal action and recovery action as shall be taken against the M/s. Muhammad Asif Govt. Contractor, in accordance with the provisions of the Act, 2011 and rules made thereunder.
