Subject: ORDER FOR PROVISIONALLY RESTORATION OF SINDH SALES TAX REGISTRATION OF M/S, BST SERVICES HAVING SNTN # S2265173-0.

This is with reference to your letter No. Nil dated 19th November, 2021 in response to this office suspension order issued vide letter of even No. 3930 dated 26th February, 2021, whereby, your registration was suspended for alleged non-filing and non-payment of Sindh sales tax amount for the tax periods July- 2019 to December 2020.

- 02. Whereas, you have submitted this office a cheque # 11092918 dated 23rd November, 2021 drawn from Bank Al-Habib Limited, M.A. Jinnah Road Branch, Karachi, total amounting to Rs 1,000,000/- as a part payment of tax amount and requested this office to restore your Sindh sales tax registration, as you filed an appeal before the Commissioner (Appeals), SRB against O-1-O No. 318 of 2021 dated 06th July, 2021 in respect of impugned demand. Moreover, you have committed to file your all pending monthly sales tax returns as well as remained compliant in future and also to deposit due Sindh sales tax timely from the date of withdrawal of suspension.
- 03. I have considered the aforesaid request of M/s. BST Services and came to the conclusion that, due to suspension of registration of taxpayer, the complete tax profile of registered person has been blocked on i.srb portal therefore the taxpayer neither can e-file their returns nor can generate the PSID on its SNTN. Since, M/s. BST Services has submitted cheque amounting to Rs.1,000,000/- and also undertake to deposit due amount of SST with SRB after due reconciliation. Therefore, taking a lenient view and for purpose of carrying on their business activity and subsequent remedial actions to be taken by the registered person, the suspension of the registered person is provisionally restored with immediate effect. In case of failing to fulfilment of stated remedial actions, registration of taxpayer may be subject to suspension.
