Subject: **ORDER FOR RESTORATION OF SINDH SALES TAX REGISTRATION NO. # S0672833-2 IN RESPECT OF M/S. AL SHAFI ENTERPRISES.**

With reference to hearing proceeding against show-cause notice NO.SRB/COM- III/Al-Shafi Ent./2020-21/7953 dated 17<sup>th</sup> June, 2021 conducted on 18<sup>th</sup> November, 2021, wherein Mr. Munawar H. Manika, Advocate and representative of M/s Al-Shafi Enterprises informed this office that, the owner of the Company has been passed away and they are facing problem to retrieve the data from their client as well as system due to suspension of their Sindh sales tax registration.

02. In addition to above, he requested this office to provisionally restore their client's registration for retrieving the data from the system and submission of proper reply against the show cause notice issued *vide* letter NO.SRB/COM- III/Al-Shafi Ent./2020-21/7953 dated 17<sup>th</sup> June, 2021.



Keeping a lenient view, I have considered the aforesaid request of the representative of **M/s Al-Shafi Enterprises** and concluded that, on suspension of registration of the registered person, the complete tax profile of registered person has been blocked on *e.srb* portal for retrieving the data and the taxpayer neither can e-file the returns nor can generate the PSID on its SNTN. Therefore, for the purpose of carrying on their business activity and submission of proper reply against aforementioned show-cause notice, the suspension of the registered person is provisionally **restored with immediate effect.**
