SUBJECT: NOTICE FOR SUSPENSION OF REGISTRATION

Whereas, section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 (hereinafter "Act, 2011") provides that registration of a registered person can be suspended where a registered person "has failed to comply with its obligations under this Act". Rule 10 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter "Rules, 2011") also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax, the Board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

- 02. Whereas, scrutiny of your tax profile reveals that you have failed:
 - to e-file monthly Sindh sales tax return (Form SST-03) as required under section 30 of the Act, 2011 read with rule 12 of the Rules, 2011, in the time limitation and the manner as prescribed under rule 13 of the Rules, 2011, for the tax periods from December 2019 to July 2020 (seven consecutive tax periods),
- Now, this notice is being issued to you under **section 25** of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Rules, 2011 to the effect that your registration is hereby suspended with immediate effect. However, your suspension shall be revoked if you take following remedial actions by <u>03rd</u> September, 2020;
 - to e-file the monthly Sindh sales tax returns (Form SST-03) for the said tax periods.
- 04. In case of non-satisfactory response or failure to take remedial measures as suggested above on or before 03rd September, 2020, your case shall be further proceeded for cancellation of your registration with SRB.

05. This notice and suspension of registration are without prejudice to the necessary legal proceedings as may be taken against you in accordance with the provisions of the Act, 2011.
