Rule 10 of the Sindh Sales Tax on Services Rules, 2011 also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax, the Board or an officer of SRB authorized by the Board in this behalf may, without prejudice to any other action under the law for the time being in force, suspend the registration of such person.

M & M FEETS visited the Office on 18.09.2023 & informed that his client received a show cause notice from SRB regarding inadmissible input tax claimed, however, he never applied for sales tax registration at SRB. M/s. M & M FEETS is registered with Federal Board of Revenue as Distributor of M/s. Bata Shoe Company in regional Tax Office (RTO) Lahore. Further, he stated that someone fraudulent person misused his name/NTN and there is no sign of any kind of taxpayer relationship/nexus with the fraudulent person.

3. Therefore, in order to verify the contention as stated above, the registration of the registered person is hereby suspended with immediate effect to safeguard that loss of revenue and further investigation.


