ORDER FOR PROVISIONAL REVOCATION OF SUSPENSION

Name & SNTN of Person Suspended:	M/S. China Energy Engineering Group Anhui No.1 Electric Power Construction Co. Ltd, (SNTN: 5240407-4)
Address:	House No. 212, Block AA, Phase 4, DHA, Lahore.
Date of Institution:	27 th January, 2023
Reason for Suspension	Non-compliance of the provision of section 8, 17 & 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods:	June 2022 to June October 2022

Whereas, M/S. China Energy Engineering Group Anhui No.1 Electric Power Construction Co. Ltd, are registered with Sindh Revenue Board having SNTN: 5244431-5, are engaged in providing or rendering taxable services of “*Construction Services*” classified under tariff heading 9824.0000 of the Second Schedule of the Sindh Sales Tax on Services Act, 2011 (referred as “**Act, 2011**”).

2. Scrutiny of tax profile of M/s. China Energy Engineering Group Anhui No.1 Electric Power Construction Co. Ltd revealed that they had failed to deposit the due amount of Sindh sales tax and also failed to file their monthly Sindh sales tax returns for the tax period **June, 2022 to October, 2022** as required under section 8, 17 and 30 of the Act, 2011 read with Rules made thereunder.

3. Accordingly, order of suspension of the registration bearing reference No. SRB-COM-IV/UNIT-03/2022/87751 dated **14th December, 2022** was served upon the registered person under section 25 of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of M/S. China Energy Engineering Group Anhui No.1 Electric Power Construction Co. Ltd was suspended against the non-payment of SST and non-filing of SST returns from (June, 2022 to October, 2022).

4. Vide letter dated 25th January, 2023, registered person requested to revoke their suspension so that they could comply with statutory requirements of law. Furthermore, they have deposited pay order of Rs.20,425,274/- against the total liability of the captioned tax periods after adjustments of their input tax (estimated figures). Further to this, registered person submitted

undertaking stating that they will submit working of actual liability and will default surcharge and penalty on or before 3rd February, 2023.

5. In view of above, taking a lenient view and for purpose of carrying on their business activity as well as subsequent remedial actions to be taken by the registered person, the suspension of the registered person is hereby **revoked with immediate effect**. In case, if taxpayer fails to comply any of the above stated remedial actions and to their undertaking, the registration of taxpayer shall be subject to suspension without further notice.

6. Registered person is also advised in his own interest to immediately e-file the monthly Sindh Sales Tax Returns and deposit the Sindh Sales Tax over and above in terms of sections 8, 9, 17 and 30 of the Act-2011 read with Rule 11, 12, 13 and 14 of the Rules-2011 failing which necessary action including imposition of penalties and re-suspension of their registration shall be initiated as per law. Please note that the returns filed by the registered person will be subject to assessment under the relevant provisions of the Act-2011.
