ORDER FOR RESTORATION OF SUSPENSION

Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder

Whereas, M/s Zamin Security Services (Pvt.) Limited SNTN# 2278665-1 are registered with Sindh Revenue Board under the category of “Security Agency” classified under tariff heading 9818.1000 to the second schedule of Sindh ...Sales Tax on Services Act, 2011 (hereinafter “Act, 2011”)

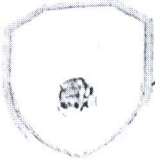
2. Scrutiny of tax profile revealed that they have failed to comply with the obligations of the Act, 2011. The registered person failed to make payments of Sindh Sales Tax on Services amounting to Rs.176,697/-, for the tax period from December 2016 to January 2018, under section 17 of the Act 2011, erroneously filed NULL SST returns for the tax period December 2016 to January 2018 under section 30 of the Act 2011 and failed to submit the printed copy of Annual Audited Accounts for the years ended 2014, 2015, 2016 & 2017 under section 26(5) of the Act 2011.

3. Accordingly, notice bearing NO. SRB-COM-II/AC-U-15/S.A/2018/993 dated 10th March, 2018 was served upon the registered person under section 25(1)(a)(ii) of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of M/s Zamin Security Services (Pvt.) Limited was suspended for the violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provision of the Act, 2011 and the rules made thereunder.

4. On 14-05-2018, 10-12-2018, 17-12-2018, 28-01-2019, and 15-04-2019 M/s Zamin Security Services (Private) limited were called upon for the hearing in the case of suspension. In the last hearing on dated 15-04-2019 Syed Kamran M Haider (MD/ Chairman) appeared for hearing, he stated that they are willing to pay subject SST dues.

5. Moreover they have submitted written submission for restoration of their registration on their letter head. Same is reproduced as under:

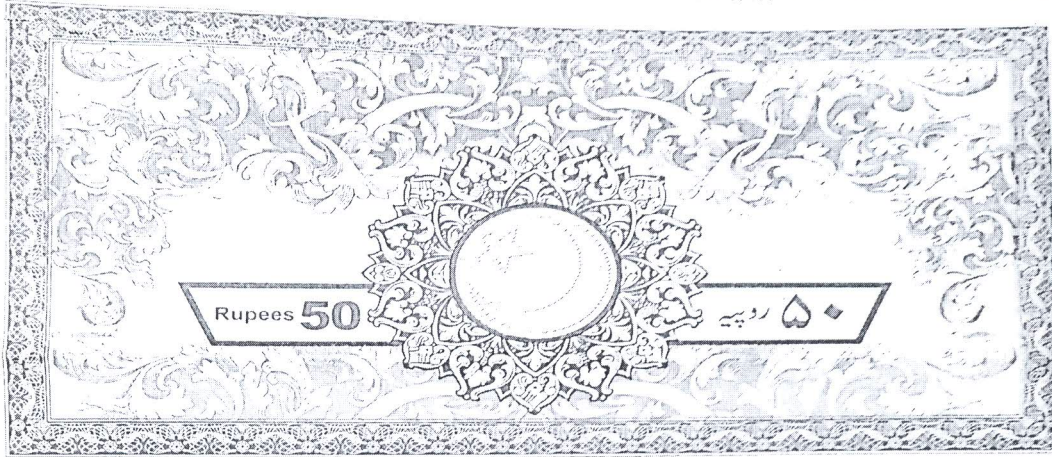

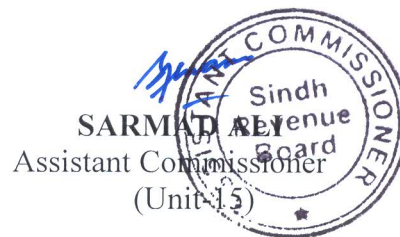

I have gone through the written submission and the contention submitted by taxpayer and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can carry out their business activities. Since, M/s Zamin Security Services (Private) limited has undertaken to comply with the provisions of the Act 2011 and will provide the record required by this office and deposit the due SST amount into the Sindh



Government's head of Account "B-02384" in the prescribed manner if it emerges out after the reconciliation of record. Therefore, taking a lenient view and for purpose and enable them to file their monthly sales tax returns under section 30 of the Act, 2011 and to pay the due SST amount, their suspension with SRB is revoked with immediate effect.
