**ORDER FOR RESTORATION OF SUSPENSION OF
M/S. S.ZIA-UL-HAQ & SONS (PRIVATE) LIMITED**

Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Period:	May 2018

Whereas, M/s. S.Zia-Ul-Haq & Sons (Private) Limited having SNTN: S3673207-9 are registered with Sindh Revenue Board under the category of “Caterers” classified under tariff heading 9801.5000 to the second schedule of Sindh Sales Tax on Services Act, 2011 (hereinafter “Act, 2011”).

2. Scrutiny of tax profile revealed that they have failed to deposit the SST amount as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as “the Act, 2011”) read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as “the Rules, 2011”) and failed to e-file the SST returns as required under Section 30 read with Rule 11,12,13 and 14 of the said Rules, 2011 pertaining to the tax periods **May-2018**.

3. Accordingly, notice bearing NO. SRB-COM-I/Unit-02/2018/0091 dated 22nd June, 2018 was served upon the registered person under section 25 of the Act, 2011 read with Circular No. 02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of M/s. S.Zia-Ul-Haq & Sons (Private) Limited was suspended for the violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provision of the Act, 2011 and the rules made thereunder before 27th of June, 2018, failing to which the case shall be proceeded for cancelation of registration.

4. On 27th June, 2018, Mr. Ahsan Metlo, representative from Ahsan & Co. appeared on behalf of M/s. S.Zia-Ul-Haq & Sons (Private) Limited for hearing wherein, he submitted pay orders of amounting to Rs.14,207,965/- (P.O No. 00043775) and Rs.8,992/- (P.O No. 00043776) for the payment of SST of May 2018. Moreover, he requested for the restoration of registration, so they can e-file the returns and subsequently generate the PSID as per the procedure defined in Act, 2011.

5. I have heard the representative of M/s. S.Zia-Ul-Haq & Sons (Private) Limited and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN. Therefore, taking a lenient view and for

purpose of carrying on their business activity and subsequent remedial actions to be taken by the registered person, this office notice dated 22-06-2018, the suspension of the registered person is hereby **revoked with immediate effect**. In case of failing to fulfilment of stated remedial actions, registration of taxpayer may be subject to suspension.

6. M/s. S.Zia-Ul-Haq & Sons (Private) Limited are further required to;
 - i. Deposit the tax amount and e-file the tax returns in the time and manner prescribed under the provisions of the Act, 2011 and rules made thereunder.
 - ii. e-file the returns by 30-06-2018
