ORDER FOR REVOCATION OF SUSPENSION

Name & NTN of Person Suspended:	M/s. Joseph Lobo (Private) Limited, SNTN- S0823659-3

Date of Institution:	19 th March, 2019
Reason for Suspension	Non-compliance of the provisions of section 3, 8, 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods:	2014-15, 2015-16 and 2016-17

Brief facts of the case are that M/s. M/s Joseph Lobo (Private) Limited bearing SNTN No. S0823659-3 are registered with SRB as a service provider in respect of Surveyors services which are chargeable to the Sindh Sales Tax ("SST") under section 8 read with tariff heading 9819.5000.

2. Scrutiny of Financial Statements revealed that they failed to deposit the SST amount as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as "the 2011-Act") read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the 2011-Rules") and failed to e-file the SST returns as required under section 30 read with Rule 11, 12, 13 and 14 of the said Rules-2011 pertaining to the tax periods of 2014-15, 2015-16 and 2016-17.

3. Accordingly, notice bearing No. SRB.COM-I/AC-16/Sur/JPLP/2018/10125 dated 19th March, 2019 was served upon the registered person under section 25 of the Sindh Sales Tax on Services Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Sindh Sales Tax on Services Rules, 2011 whereby the registration of M/s Joseph Lobo (Private) Limited was suspended for violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provisions of the Act-2011 and the Rules made thereunder before 26-3-2019 failing to which the case shall be proceeded for cancellation of registration.

4. On 27.03.2019, authorized representative of M/s. Joseph Lobo (Private) Limited namely Mr. Muhammad Yousaf has submitted their written submission and the prayer is made to revoked the instant suspension of their tax profile and authorized representative has undertaken that, the registered

person is willing to participate with positive intent in the proceedings under section 23 of the Act, 2011 pending within undersigned's jurisdiction.

5. **In view of the above request, I hereby order for the revoke of suspension with immediate effect as imposed vide this office letter dated 19th March, 2019.** The registered person is advised to participate and join the legal proceedings pending before undersigned under section 23 of Act, 2011, as required by the existing law.
