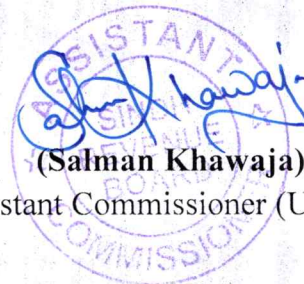
SUBJECT: SUSPENSION OF CONSECUTIVE NON-FILERS OF OPERATIONAL UNIT-31, SRB.

Whereas, section 25(1)(a)(ii) of the Sindh Sales Tax on Services Act, 2011 provides that registration of a registered person can be suspended where registered person "has failed to comply with its obligations under this Act". Rule 10 of the Sindh Sales Tax on Services Rules, 2011 also provides that where a registered person commits any act of fraud or deliberate and intentional non-payment, short payment or evasion of tax or non-filing of returns for four consecutive tax periods, the Board or an officer of SRB authorized by the Board in this behalf may, without *prejudice* to any other action under the law for the time being in force, suspend the registration of such person.

02. During the scrutiny of tax profile(s) it transpires that SRB's registered persons as per list attached (*Annexure-A*), have failed to file their Sindh sales tax monthly returns for the last four consecutive tax periods i.e. Jul-2020, Jun-2020, May-2020 and Apr-2020 (or more). This behavior of non-filing is in violation the provisions of section 30 of the Sindh Sales Tax on Services Act, 2011, read with rule 11, 12, 13, 14 of Chapter-III of the Sindh Sales Tax on Services Rules, 2011.

03. Therefore, in terms of Section 25(1)(a)(i) of the Sindh Sales Tax on Services Act, 2011 read with Rule 10 of the Sindh Sales Tax on Services Rules, 2011 and Circular No.02 of 2011, Sindh sales tax registration of seven (07) SRB's registered persons, as per attached list (*Annexure-A*) are hereby **suspended** with immediate effect until further orders.

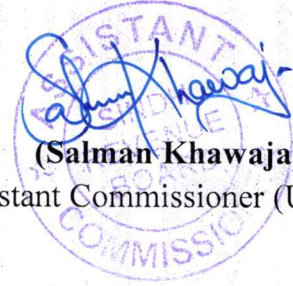
