**ORDER FOR REVOCATION OF SUSPENSION OF  
M/S. TURNOTECH (PVT.) LTD**

Name & NTN of Person Suspended:	M/s TURNOTECH (PVT.) LTD SNTN: S3400318-5
Address:	HOUSE NO. 440, STREET 28, E-11/4, NPF, ISLAMABAD.
Reason for Suspension	Non-compliance of the provisions of section 3, 8, 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder.

Whereas M/s TURNOTECH (PVT.) LTD (hereinafter referred to as the 'registered person'), having SNTN: S3400318-5 are engaged in services provided or rendered by persons engaged in "Others (Telecommunication Services)" classified under tariff heading "9812.1990" of the Second Schedule of Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as the "Act, 2011").

2. Scrutiny of tax profile of the registered person as maintained with Sindh Revenue Board revealed that the registered person has failed to make the payment of Sindh Sales Tax ('SST') as required under section 9 and 17 of the Act, 2011 read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as the "Rules, 2011"). The registered person has also failed to e-file true and correct Sindh sales tax return (Form SST-03) as required under section 30 of the Act, 2011 read with rule 12 of the Rules, 2011, in the time limitation and the manner as prescribed under rule 13 of the Rules, 2011.

3. In view of above, the registered person was served with this office notice No. SRB-COM-V/AC-01/SB/2019-20/935 dated 16<sup>th</sup> June, 2020 under section 25 of the Act, 2011 read with Circular No. 02 of 2013 and Rule 10 of the Rules, 2011 whereby registered person was suspended for the violation of aforesaid provisions of law. However, they were intimated vide supra notice that their suspension shall be revoked if they take following remedial actions:

- to Discharge due Sindh Sales Tax liability along with default surcharge under section 44 of the Act, 2011 under the Government of Sindh head of account B-02384 for the tax periods from March-2015 to July-2015, September-2015 to December-2015 and April-2016 to July-2017.
- to e-file the true and correct monthly Sindh Sales Tax returns for the tax periods from March-2015 to July-2015, September-2015 to December-2015 and April-2016 to July-2017.

4. On 21<sup>st</sup> September, 2020 vide letter No. TAX/09/021 registered person submitted a pay order of Rs.2,000,000/- bearing the CDR no. 12138764 dated 25-09-2020. Moreover, they also admitted that the remaining SST will be paid after finalization of assessment and further reconciliation. Registered person further agrees to reconcile the remaining liability amount with the department and



undertakes that once the liability is finalized it will be obliged to make the payment of remaining liability. They also requested to reinstate the registration so that they could be able to file the Sindh Sales Tax returns and deposit the due Sales tax liabilities as currently the SRB online portal does not allow both the activities.

5. I have gone through the submission of M/s TURNOTECH (PVT.) LTD and came to conclusion that, as a matter of procedure on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which taxpayer neither can e-file SST return nor can generate PSID on SNTN. Therefore taking a lenient view and for purpose of carrying on their business activity and subsequent remedial actions to be taken by registered person and till the reconciliation of the records, the suspension of registered person is hereby **revoked with immediate effect**. In case of failing of fulfillment of stated remedial actions, registration of registered person may be subject to suspension.
