SUBJECT: RESTORATION OF SINDH REVENUE BOARD REGISTRATION.

Kindly refer to this office earlier letter of even No.SRB-COM-II/DC-13/Suspension Order/01/17-18/239571, dated 25.07.2017, on the subject matter, whereby, a list of 4,338 taxpayers was shared with the request to place their SRB registration under suspension in terms of Section 25(1)(a)(iv) of Sindh Sales Tax on Services Act, 2011 and the Rules made thereunder.

02. In continuation of the above correspondence, it is to inform that so far, cases of 22 more taxpayers out of the cited taxpayers have been adjudicated, and these taxpayers have paid the penalty (for non-filing) imposed on each as per law (details are listed below), and produced relevant CPRs, in this regard, for record.

In view of the foregoing position, it is requested that the SRB registrations of the 22 taxpayers as listed below, may be restored on with immediate effect, under intimation to the undersigned, so that henceforth, these taxpayers may be able to file their due Sindh sales tax returns and pay the due amount of Sindh sales tax in the normal course.
