**ORDER FOR RESTORATION OF SUSPENSION OF  
M/S. FABCON CONTRACTORS (PVT) LTD**

Reason for Suspension	Non-compliance of the provisions of section 9, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods:	July 2013 to May 2018

Whereas, M/s. Fabcon Contractors (Pvt) Ltd having SNTN: S2812235-6 are registered with Sindh Revenue Board under the category of "Construction Service" classified under tariff heading 9824.0000 to the second schedule of Sindh Sales Tax on Services Act, 2011 (hereinafter "Act, 2011").

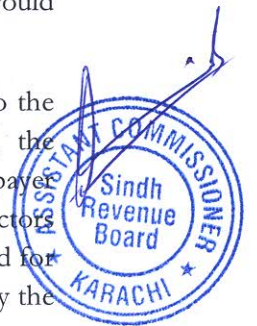
2. Scrutiny of tax profile revealed that they have failed to deposit the SST amount to the value of Rs. 11,911,359/- during the tax period July 2013 to May 2018 as required under section 9 and 17 of the Sindh Sales Tax on Services Act, 2011 (hereinafter referred to as "the Act, 2011") read with rule 14 of the Sindh Sales Tax on Services Rules, 2011 (hereinafter referred to as "the Rules, 2011"). Moreover, the registered person has also failed to e-file the correct SST returns as required under Section 30 read with Rule 11,12,13 and 14 of the said Rules, 2011 pertaining to the tax periods **July 2013 to May 2018**.

3. Accordingly, notice bearing NO. SRB-COM-I/Unit-3/2018/2817 dated 27th June, 2018 was served upon the registered person under section 25 of the Act, 2011 read with Circular No. 02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of M/s. Fabcon Contractors (Pvt) Ltd was suspended for the violation of aforesaid provisions of the law. Moreover, the registered person was required to comply with the said provision of the Act, 2011 and the rules made thereunder on or before 30th June, 2018, failing to which the case shall be proceeded for cancellation of registration.

4. On 30<sup>th</sup> July, 2018, Mr. Sabir, representative M/s. Fabcon Contractors (Pvt) Ltd appeared and submitted in written that all the invoices for M/s. Abbott Laboratories (Pvt.) Ltd are not related to M/s. Fabcon Contractors (Pvt.) Ltd. Further, they submitted that all invoices of M/s. Siemens Pakistan are paid and its details are provided. Regarding the remaining data, the details along with the CPR are provided to this office. However, in future company would ensure complete compliance to SST Act, 2011 and accordingly to rules made therein.

5. I have heard the representatives of M/s. Fabcon Contractors (Pvt) Ltd and came to the conclusion that, as a matter of procedure, on suspension of registration of taxpayer, the complete tax profile of registered person is blocked on i.srb portal due to which the taxpayer neither can e-file the return nor can generate the PSID on its NTN. M/s. Fabcon Contractors (Pvt) Ltd has provided the records for the reconciliation. Therefore, taking a lenient view and for purpose of carrying on their business activity and subsequent remedial actions to be taken by the

registered person and till the reconciliation of the records, this office notice dated 27-06-2018, the suspension of the registered person is hereby **revoked with immediate effect**. In case of failing to fulfilment of stated remedial actions, registration of taxpayer may be subject to suspension.

6. M/s Fabcon Contractors (Pvt) Ltd are further required to;
  - i. e-file the correct tax returns within three days of issuance this notice, in the time and manner prescribed under the provisions of the Act, 2011 and rules made thereunder.
