- (iii) Reason: Non-compliance of the provisions of section, 17 and 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder.

Subject: ORDER FOR REVOCATION OF SUSPENSION OF REGISTRATION OF M/S. M.R. LOGISTICS (PVT) LIMITED (SNTN: S2189037-4).

Wherein, **M/s. M.R. LOGISTICS (PVT) LIMITED** bearing SNTN 2189037-4 are registered with SRB in the service category of 'Custom Agent' classified vide tariff heading 9805.4000 to the second schedule of the Sindh Sales Tax on Services Act, 2011 'Act-2011'. As per the provisions of section 3, 5, 8, 9, 13, 17 and 30 of the Act-2011 read with rule 37 and rules enumerated in the Chapter-III of the Sindh Sales Tax on Services, Rules, 2011, the registered person had to deposit the SST and e-file the SST return [SST Form-03].

2. Reference to this office order dated 29th October, 2022 wherein the registration of the registered person was suspended in terms section 25 of the Act-2011 read with Circular No. 02 of 2013 and rules enumerated in the rule 10 of the Rules, 2011 issued against violation of section 17 and 30 of the Act-2011.

3. In compliance M/s M.R. LOGISTICS (PVT) LIMITED vide letter dated 15th September, 2023 which is reproduced as under

We would like to inform you that our registration has been suspended for the last one year, we applied for restoration and visited many time to your good office but to date our registration has not been restored. Due to this suspension we are facing many problems and our reputation is also at stake in the eyes of our clients. We cannot run our business.

Further it is submitted that since suspension we cannot make payment which has been accumulated Rs. 47,000/- as freight forwarding agent. Further it is submitted that as per notification No. SRB3-4/8/2013 we were required to pay Rs. 500/- per House Bill of Lading but inadvertently we paid Rs. 400/- we have to pay difference Rs. 100/- per House Bill of Lading as per actual calculation.


Considering the above submissions you are requested kindly restore our registration at your earliest so that we can file our monthly sales tax return as per law.

4. Based on the above submissions of the registered person and their duly undertaking regarding submission of the record pivotal for the reconciliation of the case, and for being vigilant in ensuring the timely compliance of the registered person for the deposit of SST in to the Sindh Government head of account 'B-02384' and subsequent filing of the SST returns [SST Form-03] and therefore, taking a lenient view and for the purpose of ease of doing business, the suspension of the registered person is hereby revoked with immediate effect subject to the following conditions:

- i. That the registered person shall deposit the SST so accumulated by the registered person *immediately* and the differential amount of SST recoverable in terms of rule 39 of the Sindh Sales Tax on Services Rules, 2011 and declare the same in their SST returns.
- ii. Submit the record for reconciliation of the case at the earliest.
- iii. Apply for change of category of taxable service in their registration profile.

5. In view of the above conditions and commitment of the registered person, I order to activate the User ID and Password of the registered person for depositing the recoverable SST in to the Sindh Govt. Exchequer 'B-02384' beside the levy of default surcharge under section 44 of the Act-2011 and file Sindh sales tax returns latest by or before the 15th day of November, 2023, suspension hereby stands revoked.


