## **RE-INVITATION FOR BIDS**

- 1. Sindh Revenue Board (SRB) invites sealed bids from interested bidders for Procurement of Furniture for SRB's Newly Acquired Office Space on 2<sup>nd</sup> Floor, (Northern & Southern Wings and Central Office Space), Shaheen Complex, M.R. Kayani Road Karachi.
- 2. The bidders meeting the following criteria are invited for bidding;
  - a. Valid registration with relevant tax authorities like FBR and/or SRB. (Documentary Proof shall be required)
  - b. Average Annual Turnover of PKR 10 million during the last 03 years. (Audited Financial Reports shall be required)
  - c. Bidder has successfully completed contract (s) of PKR 5 million and above for supplying/manufacturing furniture for Government/Commercial Organizations during the last three years. (Completion Certificates from the Client/Customer shall be required)
- 3. A complete set of Bidding Documents may be obtained from **21**<sup>st</sup> **October 2020 to 05**<sup>th</sup> **November 2020** during office hours (9:00 am to 5:30 pm) from the SRB officer mentioned below, on submission of a written application and payment of non-refundable Bidding Documents cost Rs. 1,000/- in shape of a pay order/ bank draft in favor of **Sindh Revenue Board, Karachi**.
- 4. Single-Stage-Two-Envelope Procedure will be adopted as per Rule-46(2) of SPP Rules 2010.
- 5. Pre-Bid Meeting shall be held at 1500 hours on 27<sup>th</sup> October 2020 at 3<sup>rd</sup> Floor, Shaheen Complex, M.R.Kayani Road, Karachi.
- 6. Bid must be accompanied with a Bid Security amounting to minimum 2% of the Bid Price in the form specified in the bidding documents. Proof of bid security must be attached with Technical Bid. The bids without bid security shall be rejected.
- 7. Partial, incomplete, conditional bids or bids received after the specified date and time will be rejected. The bids also submitted through fax, email or telegraph shall not be accepted.
- 8. Technical Bid & Financial Bid and supporting documents, in separate envelopes are required to be submitted to the below mentioned officer by **1500 hours** on **06<sup>th</sup> November**, **2020**. Technical Bids shall be opened on the same date at **1530 hours** in presence of the bidders' representatives & the Procurement Committee. Bids received after prescribed time/date shall not be entertained. Financial Bid of only post-qualified bidders shall be opened on a date communicated later.
- 9. Procuring Agency reserves the right to reject all or any bid subject to relevant provision of Sindh Public Procurement Rules 2010.
- 10. In case the bids are not opened on the scheduled date due to unscheduled holiday or any other reason, the same shall be opened on the next working day. Other terms and conditions of the bids shall, however, remain unchanged.
